### Staff Report

### Origin

The closure of River Road between No. 2 Road and Hollybridge Way is required to facilitate the construction of the Oval and redevelopment of City land at 6080 River Road.

## **Findings Of Fact**

River Road has been physically closed to traffic between No. 2 Road and Hollybridge Way. Traffic has been diverted to Westminster Highway between these two points.

Council approval of the Road Closure and Removal of Highway Dedication Bylaw 7975 (Attachment 1) is required to formally and legally close the road.

A new, diverted River Road will be constructed early in 2006, providing vehicle access from the river at No. 2 Road to the old CP rail allowance, which will become a new east/west road link to Hollybridge Way and eventually beyond to Gilbert Road.

#### **Analysis**

To close a road and remove the previous dedication of the road the City must:

- (1) enact a Highway Closure Bylaw following public input and delivery of notice of the intention to close the road to operators of utilities;
- (2) enact a Removal of Highway Dedication Bylaw following public input.

The consolidation of the closed road with the City's lands, dedication of the new, diverted River Road and creation of the new road over the old CP rail lands will be accomplished by deposit of a subdivision plan at a later date.

Telus is the only private utility company that has works within the portion of River Road that is to be closed. Engineering staff are working with Telus on relocation plans.

Public access to the dyke and trail, on the north side of the closed road, will not be affected. Vehicular access to the dyke for maintenance will be preserved.

#### Financial Impact

Surveying, advertising and registration costs will amount to approximately \$1,620.00.

#### Conclusion

Council approval for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> readings of Bylaw 7975 is required at this time, so that staff can proceed to finalize the matter.


