I wish to be a delegation at the Next Richmond City Council Meeting.

I have two issues below:

1. How can council make a recommendation without first hearing from the person speaking at the council meeting? The last time I was at a council meeting, council made recommendations to deny, before even hearing me at the council meeting. What kind of system is this?

2. If big trucks can't park in Residential areas because of noise and weight, and they are over 5000 kg's, then overhead (metal bin) garbage trucks, motorhomes, etc., shouldn't be permitted in Residential areas because of noise and weight either. I do have Richmond City on tape saying the reason that large trucks are not permitted to park is because of noise and weight. Garbage trucks are heavier and noisier than the Tractor Portion of a Semi Unit. It was only the Tractor portion I was requesting the City of Richmond to allow to park in Residential neighborhoods. My bedroom wall is next to a metal garbage bin that gets emptied every Saturday morning at 7:30 AM by BFI, which wakes me up. The recycle truck that emties the large blue plastic bins next to my bedroom wall and the cars that park against my bedroom wall do not wake me up, but the metal bin garbage truck does wake me up, as it sounds louder than thunder. Both BFI and Westsea Construction (Sussex Square Apartments where I own my Apartment) won't change the garbage pickup time. I would like to see (metal bin) garbage pickup in Residential areas after 9 AM. BFI claims they have to do a pickup at the Airport that early and that is why the garbage here is emptied Saturdays at 7:30 AM. I was told over the phone by Westsea Construction that they are with the service that BFI provides, and that Westsea will not be changing garbage companies. I received a letter from Westsea stating that I should move if I don't like the noise. I have have submitted letters from residents at Sussex Square Apartments that also don't like the noise the garbage truck makes.

Its too bad that it has to come to this (bugging the City of Richmond), as it seems Westsea Construction and BFI have no common sense. Hopefully the City of Richmond will have some common sense and make a bylaw for BFI. The City of Richmond has contacted and spoke with BFI on this issue to no avial.
