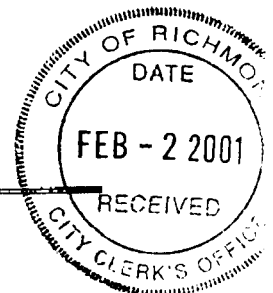

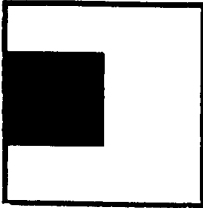

**Re:** Progress Report

**Past:** To date we have had four neighbourhood meetings and one general meeting at Richmond City Hall in response to receipt of the City of Richmond by-law violations for ditches and boulevards in the Broadmoor area. Every City Councillor has been telephoned to ask them for help with our problem. To date, we have received no proposals or offers to resolve our concerns.

**Present:** At present we are preparing a letter to The Public Works Committee with copies to council and mayor stating our request for an indefinite delay on By Law 9015 effective immediately. We are asking for a meeting with the Public Works Committee to share the many issues raised at the public meeting at City Hall.

**Future:** We expect The Public Works Committee to approve our request to delay action indefinitely to allow time to determine what strategies may be considered to not only address the ditch problem but a larger issue, the development of a plan that would let the citizens of Broadmoor know the overall plan for ditch infill, sidewalks and street lighting in our neighbourhood. If denied, we will approach City Council for a hearing.
