#### Staff Report

#### Origin

At the meeting of the Parks of the Parks, Recreation and Cultural Services Committee meeting held on Tuesday, June 24<sup>th</sup> 2003, the following was referred, "That staff review the maintenance procedures of McLean Park and include in the report back to Committee input from the area residents". This referral is in response to that request.

#### **Analysis**

In 1997 staff, a community group and consultants commenced the planning for McLean Park site. This group met once a week for three months to come up with a concept plan that was affordable and met the community needs. This process culminated in the plan being presented to the community at a public information meeting held in April 1997 (see Attachment 1). The plan identified that a naturalized meadow area would be incorporated into the park site. The plan as well received by the community. Council approved the plan and the park was constructed as planned later that year.

The meadow areas of McLean Park comprise about five acres of the 11 acre site. They are intended to enhance the environment and encourage passive activities, and are placed strategically to provide a buffer between the active park areas and the residences that abut the park.

There are pathways running through the meadows with closely mowed strips on each side of the pathway for maintenance and safety reasons. The meadows are shaped to enhance the design along contour lines and this park has been recognized as a great example of naturalization by the Communities in Bloom program.

Overall there are currently 26 parks in the park inventory that have long grass areas as part of the design. The size of the area in each park ranges from almost all to token patches and the total of all areas is 139 acres (see Attachment 2).

Although these areas in parks are found world-wide, some people have trouble accepting this concept in neighbourhoods where most yards are manicured. There are a few calls every year from residents of such areas concerning rodent problems, allergy sufferers, safety issues, potential fire hazard, weed encroachment, and just plain aesthetics. These concerns have been answered individually. There are also calls from residents who don't want these areas cut at all.

To manage these concerns, strategies have been adopted to ease the concerns. They are:

- The meadow concept is a part of plans for new parks only although the principle could apply to established parks everywhere. This has been in place for the last 10 years.
- There are one or more rough cuts per year to control noxious weeds, blackberries and brush where it is not wanted.
- A buffer zone of close mowed grass between meadow areas and private lots reduces concerns of invasion of weeds and rodents as well as concern over fire hazard.

• Wild flowers are planted with the specialized grasses. However, they will probably be choked out by aggressive species of grasses and clover

Staff have consulted with the Hamilton Community Association on this matter. The consensus was that the meadow area is acceptable and can be enhanced by wildflower or bulb planting and an addition flail mowing annually.

### **Financial Impact**

If the level of grass cutting service were to change on McLean Park from rough to manicured cut, the financial impact is summed up in the following table.

The impact on the Operational Budget for McLean Park would amount to an additional \$9,805 in the first year and \$2,305 in subsequent years.

#### Conclusion

The present level of service with some minor adjustments is acceptable to the community. For both environmental and financial reasons, the present maintenance procedures would appear to be worth sustaining.


