Staff Report

On May 9, 2005, Council adopted Fee Establishment Bylaw No. 7889 for various RCMP Services. At the time of consideration, General Purposes Committee directed staff to bring forward annual increases in the fees based on increases to the consumer price index. Fee Establishment Bylaw No. 7889, Amendment Bylaw No. 8051 provides for a CPI increase to the RCMP service fees as directed, based on an annual average increase in CPI of 2.0% as determined by Statistics Canada for 2005.

Conclusion

That Fee Establishment Bylaw No. 7889, Amendment Bylaw No. 8051, which increases RCMP service fees in accordance with CPI increases, be introduced and given first, second and third readings.

Fee Establishment Bylaw No. 7889, Amendment Bylaw No. 8051

The Council of the City of Richmond enacts as follows:

1. Bylaw No. 7889 is amended by deleting Section 1.1 in its entirety, and by substituting the following:

1.1 Establishment of Fees
