

STAFF REPORT

On January 17th, 2005, the General Purposes Committee endorsed a series of fee increases to cover the cost of services provided by the RCMP and directed staff to bring forward the appropriate bylaw, which is attached. Committee also directed that annual increases to these fees be brought forward based on the cost of living allowance. Such annual increases require bylaw amendments and these will be brought forward at or near the beginning of each year.



Fee Establishment Bylaw No. 7889

The Council of the City of Richmond enacts as follows:

PART ONE: RCMP SERVICE RECOVERY FEES

1.1 Establishment of Fees

1.1.1 The following fees for the recovery of costs associated with the provision of services provided by the RCMP, are established:
