#### Staff Report

#### Origin

Jodie Shebib started her employment with the City of Richmond as Supervisor, Community Bylaws for the purposes of bylaw enforcement on March 20, 2006.

### **Analysis**

It would be appropriate to provide the new Supervisor, Community Bylaws the ability to issue both Municipal Ticket Information and Parking Bylaw Violations.

Under provisions of the Offence Act, for the purposes of the issuance of a violation ticket and / or service of summons in respect of an alleged offence under a bylaw of a Municipality, a Peace Officer includes Bylaw Enforcement Officers as appointed under the Police Act.
