Staff Report

Bylaw No. 7889 was given first, second and third readings on Monday, April 11th, 2005, and since then it has been determined that the *Motor Vehicle Act* does not permit the charging of fees for a “Chauffeur’s Permit”. Unfortunately the terminology used in the preparation of the schedule which was the basis of the bylaw used the term “Taxi Permit” instead of “Chauffeur’s Permit” and this was not detected at the time the bylaw was prepared. The proposed amendment eliminates the fees for Taxi Permits (Chauffeur’s Permits) but this should result in no net loss of income as a fee remains in the bylaw for a Criminal Records Check which is one of the standard processes prior to the issuance of a Chauffeur’s Permit. Nevertheless it is important that this correction be made to the bylaw.



Fee Establishment Bylaw No. 7889

The Council of the City of Richmond enacts as follows:

PART ONE: RCMP SERVICE RECOVERY FEES

1.1 Establishment of Fees

1.1.1 The following fees for the recovery of costs associated with the provision of services provided by the RCMP, are established:

(l)	Mechanical Inspection Report	\$ 214.00
(m)	Police Report and Passport Letter	\$ 50.00
(n)	Insurance Claim Letter	\$ 50.00
(o)	Court Ordered File Disclosure	\$ 50.00 plus \$.50 per page, and \$ 6.00 shipping

(p)	Photos (4 x 6)	\$ 1.75 each plus \$ 6.00 shipping
(q)	Photos (each laser)	\$.99
	Burn CD	\$ 16.05
(r)	Video Reproduction	\$ 40.00
(s)	Audio Tape Reproduction	\$ 40.00
