- (2) That staff review Bylaw No. 1988 and prepare amendments to the existing Bylaw to eliminate any redundant clauses and to modernize the Bylaw;

- (3) That the Richmond School District No. 38 be asked to proceed with enabling legislation to allow for the ticketing and or removal of persons from school property;
- (4) That City and School District staff prepare an information pamphlet to be distributed in the Richmond School System at City recreation facilities, through the existing Neighbourhood Watch program, and in the Community Police Stations to inform the community of:
 - (a) existing City and School District initiatives to combat vandalism;
 - (b) details of the cost and scope of recent or common acts of vandalism;
 - (c) contact phone numbers for reporting acts of vandalism; and
- (5) That the City in partnership with the School District, develop and implement an educational program in Richmond's School System on the issue of school/park vandalism.
- (6) That the City and the School Board co-host a public meeting to listen to public concerns and options about the above recommendations; and that staff report to Council through the Council/School Board Liaison Committee on the results of the public meeting.
