Staff Report

As per Committee's request attached is a summary of the transfer to reserves budgeted under the 5 Year Financial Plan. The amounts budgeted are as follows:

2002 \$ 8,884,102 2003 \$ 9,785,109 2004 \$11,625,571 2005 \$11,242,174 2006 \$11,772,236

The items making up the transfers are costs that would normally be budgeted as regular operating expenses (i.e. depreciation expenses) and are well below the required amounts required to properly fund the reserves. The following is a brief explanation of each of the transfers:

Public Works Equipment – this is the amount put towards replacement of the Public Works vehicle fleet.

Fire Equipment – this the amount put towards replacement of Fire Rescue equipment.

Mechanical Equipment – this is for replacement of all mechanical equipment such as boilers, dryers, etc.

Industrial Use – this is for the purchase of Land

Revolving Use – these are actual internal loan repayments of principal and interest borrowed at 3% interest rate over 12 years.

Damage Claims – this amount is put aside for damage claims below our insurance deductibles.

Capital Buildings and Infrastructure – this amount has been put aside for the minor public works and minor building extended maintenance programs – annual contribution to the program.

Parks Capital – this amount has been put aside for minor and major parks extended maintenance programs – annual contribution to the programs.
