ORIGIN

A Request for Proposal for banking services was sent out in November 1999. Staff took the initiative to request an overdraft facility of 3 million dollars as part of the banking services agreement.

Council approved the appointment of The Bank of Nova Scotia (Scotiabank) on February 21, 2000, as the new banking partners for the City of Richmond ("City") for a period of three years and three months.

The overdraft facility has been granted and is subject to compliance of a Special Resolution authorising the utilisation of this facility.

ANALYSIS

The overdraft would be utilised to cover the unforseen shortfall in the daily cash requirements of City operations.

SPECIAL RESOLUTION

WHEREAS the City Council of the City of Richmond (the "Corporation") deems it necessary to borrow the sum of three million dollars (\$3,000,000.00).

BE IT THEREFORE ENACTED as a Special Resolution as follows:

- 1. The City of Richmond is hereby authorised to borrow on behalf of the Corporation from THE BANK OF NOVA SCOTIA (the "Bank") from time to time by way of promissory note or a sum or sums not exceeding at any one time three million dollars (\$ 3, 000,000.00).
- 2. The Mayor and City Clerk are hereby authorised to sign on behalf of the Corporation and to furnish to the Bank from time to time a promissory note or notes sealed with the corporate seal for the sum or sums to be borrowed with interest at such rate as the Bank may from time to time determine.
- 3. The Mayor and City Clerk are hereby authorised and directed to apply in payment of all sums borrowed from the Bank, with interest thereon, all of the moneys hereafter collected or received on account or realised in respect of the taxes levied for the current year and for any preceding years and all of the moneys collected or received from any other source.
