## Staff Report

## Origin

The provincial Liquor Control and Licencing Branch (LCLB) issues licences under the authority of the Liquor Control and Licencing Act and Regulations.

The LCLB, notifies local government to give them the opportunity to provide comments and recommendations to the LCLB on all liquor licence applications.

This report will deal with the application from Viva Club at 7920 Cambie Rd requesting an extension of hours on Sunday through Thursday until 2:00 a.m. and Friday and Saturdays until 3:30 a.m.

### Analysis

Viva Club has applied to the Province to extend their hours of operations Sunday through Thursday until 2:00 a.m. and Friday and Saturday until 3:30 a.m. Presently the hours of operation are 7:00 p.m. to 12 midnight Sunday, Monday through Saturday 7:00 p.m to 2:00 a.m. Friday and Saturday.

The Provincial Liquor Licensing process requires the City to provide resolution based on the comments received from the residents and agencies in the City in the following areas:

- o the potential for noise
- o impact on the community
- o views of the residents

The public process required the posting of a sign notifying the public of the application for a minimum of thirty days; three advertisements placed in the local paper and letters sent to residents within 50 metres of the establishment requesting their comments on the extension of hours for the Viva Club. The thirty-day time frame lapsed April 16<sup>th</sup>, 2004.

Comments from the residents	Resident's views were gathered as outlined in the process above. Five (5) letters were received (Attached) 1 letter objects; and 4 letters are in agreement. Those in agreement:  one is from the landlord one from Broco Auto Glass; Hanson Travel and the final one with no comments	were:  crime and other activities, which create problems.  The letter from the landlord states they are good tenants and the others reference them as good neighbours.
RCMP Comments	The RCMP was asked to comment on this establishment and the calls related to Viva Club.	Police have attended Viva Club 46 times in the past 2 years. The offences have included:  o impaired driving, o assaults, o assaults with weapons causing bodily harm, o assault against the police, o firearm related offences including discharge of firearms o overcrowding o over service and o minors o gang activity involving firearms and drugs. The impact of these call outs drastically impact the RCMP resources throughout the City and a direct to the City. With an increase in hours the problems and cost to the city would increase.

Since the introduction of the new Provincial Liquor regulations, Council has expressed a strong concern against extension of hours for liquor establishments in Richmond. Research from the City of Vancouver shows the additional costs and the tax on staff resources that are born by the city when hours are extended to establishments.

Staff recommend that the request for extension of hours by the Viva Club be denied for the following reasons:

- lowing reasons.
- Increase in police manpower, which is an additional cost to the City. Police resources do not exist to deal with the extension of hours and the negative impact extended hours has on the community.
- Negative impact on community of Richmond at large based on the activities sited by the RCMP.
- Increase in crime and gang activity involving firearms and drugs.
- Increase in violent crime and assaults with weapons as stated in the police comments.

#### Conclusion

Staff have completed all necessary reviews and recommend Council not extend hours of operation for the Viva Club at 7920 Cambie Rd. due to the reasons stated.

We no longer feel safe on our city streets later at night. Just look at the late night speeding which happens regularly up Gilbert.

In the Richmond News, April 10, 2004 edition, page 8, Councillor Derek Dang states "our fire and police costs have been exceeding our target. This council has to find the means to finance these ... very important departments." What more strain will this have on our policing costs to have this location open later selling alcohol.

We do not want this licence approved.

Sunday through Thursday: to 2:00 a.m. Friday and Saturday: to 3:30 a.m.

Viva Club has reported that their sales have decreased dramatically since the Vancouver club hours were extended to 4:00 a.m. Many patrons simply now go to Vancouver for the opportunity of extended hours. Viva Club believes their business survival requires them to have a level playing field with the competition in Vancouver.

We have never received a liability insurance claim on either persons or property regarding Viva Club or their business. Viva Club is a night club, not a pub, and is located in a commercial area away from residences.

As Viva Club's Landlords, we support their application for extension of hours at their location.
