Full Service Gaming Policy

Staff Report

Origin

On May 29, 2002 Council adopted the Full Service Gaming Policy (Attachment 1) after a public consultation process. The definition of a "Full Service Casino" in the policy reflected the Provincial Government policy of the day regarding the maximum allowable number of gaming tables, poker tables and slot machines permitted at a full service casino. Since the date of the adoption of the City policy, Provincial Government regulations and policy have changed and Council policy is now out of step with the new regulations and policy. The Council policy should be amended (Attachment 2) so that there is consistency in the City policy and the Provincial Government regulations and policy.

Analysis

By simply amending Council's policy on Full Service Gaming to reflect the current Provincial policy for a Full Service Casino, the City would become consistent with Provincial Government policy. This will ensure efficiency in our administration of Council policy such that we will not have to continually adopt changes in our policy every time a Provincial regulation or policy is amended.

Financial Impact

At this time there is no financial impact associated with this change.

Conclusion

That the Full Service Gaming Policy be amended in accordance with the recommendations in the report dated April 9, 2003 such that the City policy be consistent with the Provincial Government regulations and gaming policy on this matter.

- up to 300 slot machines.

 - b) Council will specify the type of consultation at the time.
 - c) The following factors will be considered
 - social
 - economic/financial
 - land use
 - transportation
 - servicing
 - environmental
 - other, as necessary.

(2) Referrals From Adjacent Municipalities

When Richmond receives a request for comments regarding casino proposals in adjacent municipalities, Council:

- a) may seek public input and specify the type of consultation at the time.
- b) will consider the following factors when commenting.
 - social
 - economic/financial
 - land use
 - transportation
 - servicing
 - environmental
 - other, as necessary

3. Zoning

Casino proposals will be considered on a site specific basis and may be managed by CD zoning.
