STAFF RECOMMENDATION

It is recommended that:

- 1. Existing driveways accessing Williams Road between No. 4 Road and No. 5 Road in contravention of Williams Road Access Bylaw No. 3967, be eliminated gradually through attrition as the properties are redeveloped,
- 2. The request for Williams Road access from 10440 Williams Road be denied.
- Upon adoption of the pending City Lane Policy, Williams Road Access Bylaw No. 3967 be reviewed and revised to suit the City Lane Policy and the City Single Family Residential Development – Access Policy 5003.

STAFF REPORT

<u>ORIGIN</u>

At the May 3, 2000, Public Works & Transportation Committee meeting, Committee referred the report (dated April 20, 2000, from the Director of Engineering), regarding the request for Williams Road access from 10440 Williams Road to staff for the compilation of a history of the 24 driveways suggested by Mr. Cokar to be in contravention of Williams Road Access Bylaw No. 3967, and for recommendations regarding these driveways.

<u>ANALYSIS</u>

A site investigation by staff confirmed that there are 66 driveways currently in existence along Williams Road between No. 4 Road and No. 5 Road. The locations of these driveways are tabulated in Appendix A to this report. According to Williams Road Access Bylaw 3967, 42 driveways are approved along Williams Road from No. 4 Road to No. 5 Road. Therefore, there are 24 driveways along Williams Road between No. 4 and No. 5 Road which do not comply with Bylaw No. 3967.

Williams Road Access Bylaw 3967 was enacted on June 22, 1981. Until 1997, Williams Road consisted of strip pavement construction without curb and gutter. Therefore, it was difficult to prevent the construction of new accesses onto Williams Road.

Williams Road was re-constructed with the addition of curb, gutter and sidewalk in 1997 and 1998. In 1997, the portion from No. 4 Road to Shell Road was re-constructed. In 1998, the remainder from Shell Road to No. 5 Road was re-constructed. The addition of curb and gutter made the construction of new accesses onto Williams Road more difficult.

Williams Road construction records from 1997 and 1998 indicate that the additional driveways along Williams Road, which do not comply with Bylaw No. 3967 were allowed to remain in place during the Williams Road re-construction project because of historic use. The fact that this portion of Williams Road was without curb and gutter prior to 1997 makes it difficult to determine the duration of the historic driveway use because it was relatively easy for residents to establish driveways before the curb was installed. Therefore, all historic driveways received curb letdowns for the driveway crossings during reconstruction of Williams Road.

In the case of Mr. Manzoor Cokar's request to access Williams Road from his property at 10440 Williams Road, Mr. Cokar would like a new driveway in conjunction with his building permit for his new home at 10440 Williams Road.

Review of available building permit records indicate that historically, no new driveways were installed in conjunction with the issue of a building permit for construction of a new home since Bylaw 3967 was enacted in 1981, with one exception. In 1983, the property at 10000 No. 4 Road was subdivided resulting in a new lot at 10040 Williams Road. A building permit for a new home at 10040 Williams Road was issued in June of 1984, and a driveway access from Williams Road was also provided. In 1997, when Williams Road was reconstructed, this driveway was considered historic and a driveway crossing was provided.

FINANCIAL IMPACT

There is no financial impact anticipated as a result of the recommendation.

CONCLUSION

Twenty four driveways currently exist along Williams Road from No. 4 Road to No. 5 Road which do not comply with Williams Road Access Bylaw 3967. Only one of these non-complying driveways was installed in conjunction with the issue of a building permit for new house construction. Therefore, the provision of a new driveway which does not comply with Bylaw 3967 in conjunction with construction of a new home along this section of Williams Road is considered an anomaly and was likely inadvertent in the single case where this occurred.

Construction records indicate that during the reconstruction of Williams Road in 1997 and 1998, driveways that did not comply with Bylaw 3967 were allowed to remain in place because of historic use.

In keeping with the City's pending lane policy, existing driveways along Williams Road between No. 4 and No. 5 Road should eventually be eliminated by attrition as re-development occurs. No new driveway accesses should be permitted along Williams Road between No. 4 and No. 5 Road.
