#### **OTHER BUSINESS**

#### Potential Proposal to Export Waste to the U.S.

Received

Chair Jackson, informed the Board that the Minister of Environment has met with representatives from Cache Creek, Ashcroft and Lytton to discuss Metro Vancouver's plan to export waste to Washington State. The Chair expressed concerns that the Minister noted his Ministry has not yet received the application from Metro Vancouver to amend the Solid Waste Management Plan to export the solid waste to the United States.

The Board was informed that an application to amend the Solid Waste Management Plan to export solid waste to the United States on a temporary basis (for a five-year period) had been submitted to the Ministry of Environment regional office, and that a Request for Proposal is being prepared for a long-term, waste-to-energy solid waste disposal.

#### **Request of Staff**

Staff was requested to provide the Board with a copy of the application to amend the Solid Waste Management Plan to export the solid waste to the United States, submitted to the Ministry of Environment.

#### **INVITED PRESENTATIONS**

## Libby Davies, NDP Vancouver East, Member of Parliament

Libby Davies, Bill Siksay, Peter Julian, Penny Priddy, and Dawn Black, BC NDP caucus, were present to discuss urban issues affecting Metro Vancouver, including:

- The impact of downloading on local communities
- Increase of the number of homeless people in the region as an indicator of deteriorating regional social and economic situation
- · Loss of affordable housing units
- Specific targets not being established by the federal government to address climate change and to move towards international commitments
- Decline of the CMHC role in providing social and affordable housing
- Money spent on housing pilot projects rather than on programs that would provide affordable and social housing
- Residential rehabilitation and homeless programs not being renewed beyond March 2009
- · Federal government's lack of commitment for funding culture
- The impact of the Bill C-10 on film industry
- Disbandment of the CBC orchestra
- · Growing infrastructure deficit
- Funding for the Gateway project being below the funding that should be contributed by the federal government
- Emphasis on temporary foreign workers
- Decrease of transfer payments from federal to provincial government resulting in the reduced quality of health care
- Shortage of police officers
- Deficit around public safety (roads, ports, electricity grids not being maintained)
- Illegal drug and weapon smuggling
- Lack of national disaster emergency plan and national disease plan
- Lack of federal government funding for dyking

The following was suggested in response to some of the issues raised above:

- The importance of encouraging rental housing market
- Shift from housing pilot projects to programs that would provide housing
- Private Member's Bill C-377, setting out interim greenhouse gas emissions targets, has been prepared in response climate change concerns
- Private member's bill has been tabled to encourage rental housing market
- Housing Bill of Rights, addressing the need to create a national affordable housing strategy, has been introduced
- Twinning of the Port Mann Bridge will not solve the transportation issues, money would be spent more effectively if invested in public transit and transportation alternatives

 The role that the federal government could play in health care: education of health care professionals, revision of code of practice, national drug strategy, national databases, provisions enabling (health care professional) immigrants to work in the field of their expertise

#### Discussion ensued on:

- Concerns about qualified immigrants, such as health care professionals, not being able to utilize their skills
- Importance of a national housing strategy
- The need for long-term funding for programs dealing with mental health, drug use, and homelessness
- The Riverview project
- · Concerns about the disbandment of the CBC orchestra
- The need of the federal government to be actively involved in climate change actions

Backgrounder titled "Metro Vancouver – Intergovernmental Relations" was distributed at the meeting and is retained with the April 25, 2008 Board agenda package.

#### **DELEGATIONS**

## George Harvie and Kip Gaudry, The Corporation of Delta

Heard

George Harvie, Chief Administrative Officer, and Kip Gaudry, Director of Community Planning and Development, The Corporation of Delta, spoke in support of the Corporation of Delta request to remove a portion of land in the Tsawwassen Golf and Country Club (TGCC) site from the Green Zone. The project met the Board requirements from the June 2007 Board meeting, provides a net benefit to agriculture, and conforms with Delta's commitment to sustainability and reduction of greenhouse gas emissions.

#### Peter Guichon, Director, Delta Farmers' Institute

Heard

Peter Guichon, Director, Delta Farmers' Institute (DFI) spoke in support of the removal of a portion of land in the Tsawwassen Golf and Country Club (TGCC) site from the Green Zone. DFI concluded that the proposed land is not viable for agriculture due to poor soil conditions and no irrigation in place; the land has not been farmed for 25 years. Agriculture community, region and the Corporation of Delta will benefit from 148 acres returned by the developer to the agriculture reserve fund (with a covenant that the land must be actively farmed) and from a \$300,000 donation toward wildlife habitat creation elsewhere in Delta.

## Ron Toigo, Managing Director, Shato Holding Ltd.

Heard

Ron Toigo, managing director, Shato Holding Ltd., and Ross Clouston, project manager, Talisman Homes Ltd., requested the Board to support the Land Use and Transportation recommendations adopted in favour of the TGCC redevelopment, highlighting the following:

- The project met directives from the June 2007 Board meeting. The project received Agricultural Land Commission approval and went through an extensive consultation process.
- 10.6 acres of farmland, currently zoned industrial, will be re-zoned to agriculture and dedicated to the Corporation of Delta.
- The developer will rezone and put an active-farming covenant on additional 150 acres of land.
- The proposal has been approved by Delta Council, the Agriculture Land Commission, and Delta Farmers' Institute.
- The proposal has received public and business community support.
- A number of environmental initiatives are incorporated in the project.

## Kent Warmington, Delta resident

Kent Warmington, Delta resident, spoke in opposition of the proposed TGCC redevelopment. The delegate expressed concerns about:

- The diminishing supply of Delta's farmland due to high farm prices caused by real estate development speculation
- The precedent setting nature of the amendment (the impact on the remaining agricultural land)
- The loss of Delta farmland due to port expansion requirements, the Tsawwassen First Nation's treaty settlement lands, the South Fraser Perimeter Road and other developments

The Board was requested to refer the consideration of the application to the Regional Growth Strategy review process.

Request from the Corporation of Delta to Amend the Livable Region Strategic Plan Green Zone (Tsawwassen Golf and Country Club)

The Board gave first and second reading to "Greater Vancouver Regional District Livable Regional Strategic Plan Amendment Bylaw Number 1077, 2008", to remove a portion of the Tsawwassen Golf and Country Club from the Green Zone to enable a housing development in conjunction with a golf course on the Tsawwassen Golf and Country Club site.

The Board directed staff to schedule a public hearing related to Bylaw No. 1077, 2008.

The Board accepted the Corporation of Delta's request to amend the Livable Region Strategic Plan Green Zone and requested the Corporation of Delta to submit a Regional Context Statement Amendment to be processed concurrent with or subsequent to the Bylaw No. 1077, 2008.

The Board accepted the Corporation of Delta's request to amend the Livable Region Strategic Plan Green Zone and directed staff to bring forward an amendment to the Fraser Sewerage Area boundary following the approval of the Green Zone amendment Bylaw No. 1077, 2008 by the Board.
