Staff Report

Origin

The most recent amendment to the Dog Licencing Bylaw No. 7138 was given first, second and third reading at the regular Council Meeting of May 30, 2005 and adopted at the regular Council Meeting of June 13, 2005. The Schedule A of applicable Licencing Fees was amended as part of the process.

Analysis

Unfortunately, as part of the amendment process, the existing Schedule of Fees was inadvertently deleted and a Schedule of Fees was substituted that would not come into effect until 2006.

Therefore, with the adoption of the Dog Licencing Bylaw No. 7138 on June 13, 2005, there are no effective fees in place for the sale of Dog Licences for the balance of 2005. In addition, the format of Schedule A covering Licence Fees was confusing and subject to various interpretations as to categories and effective dates.

Staff has reformatted the Schedule to ensure that there is an applicable Schedule of Fees in place to cover sales for 2005 and only one interpretation as to the categories of dogs and the effective dates of the fee changes.

Financial Impact

Given that this is only a clarification to the original Schedule and there is no change to the applicable fees, we do not foresee any financial impact to adoption of this amendment.

Conclusion

Staff recommends adoption of the amended Schedule of Fees.

The Council of the City of Richmond enacts as follows:

1. Schedule A to Bylaw No. 7138 is amended by deleting the existing schedule and substituting the following:
