Staff Report

Origin

Staff have received a proposal from Steveston Judo Club which details the corporate sponsorship of a street banner program for the area: Moncton Street between Third Avenue and No.1 Road (Attachment 1). The purpose of this report is to recommend a process for undertaking the street banner proposal in June 2003.

Analysis

2003 marks the 50th Anniversary of the Steveston Judo Club. To help celebrate this event, the club will be hosting a series of dignitaries from Japan and several special events including the North American Sumo Basho on August 23, 2003.

Proposal

The proposal from the Steveston Judo Club (SJC) involves the following:

- The production of 20 street banners to be placed along Moncton Street between Third Avenue and No. 1 Road and potentially on two banner poles along Bayview Street for a period of four months beginning in June 2003 and ending in September 2003.
- SJC will sponsor 100% of the cost of installation, removal and production of the banners.

Enabling Policy

As per Section 6 of Policy 7703, the following policy guidelines are supported by the SJC proposal:

"Cost to Sponsor: Interested sponsors would be responsible for the cost of manufacturing, installing, and removing banners, and providing hardware--if not already in place--and removing and replacing hardware and banners which are damaged."

Examples of Similar Street Banner Sponsorship Initiatives

The SJC corporate sponsorship street banner proposal complements six recently corporately sponsored and/or recycled street banner initiatives:

- Onni Group of Companies: involved the sponsorship of street banners in and along the Imperial Landing area in 2003;
- Telos Technologies Initiative: involved the sponsorship and provision of hardware for 38 street banners along Jacombs road in East Richmond in 2001;

- Progressive Construction Initiative: involves the ongoing financial sponsorship of recycled street banners from previous years community competitions, the supply of hardware and annual financing for the installation/removal of banners outside the city centre on Barnard Drive in Terra Nova;
- Royal Bank Initiative: involved the sponsorship of street banners along Minoru Boulevard to recognise the 1999 United Nations International Year of Older Persons, banner tail flags were used to recognise the Royal Bank as 'proud sponsor';
- Asia International Services Corporation (AIC) Initiative: involved the sponsorship of street banners along No.3 Road, Hazelbridge Way and Cambie Roads in 1998/1999, banner tail flags were used to recognise AIC as 'proud sponsor';
- Steveston Village: involves the annual recycling of City Centre Street Banners along Moncton and Bayview Streets in Steveston.

Banner Design

Attached (Attachment 2) is the proposed design for the SJC banner display. The banner design represents a cherry tree blossom supporting the strong Japanese cultural heritage of Steveston. Staff recommend approving this design which will contribute to and complement the character of Steveston Village for the duration of the display.

Financial Impact

The proposal from SJC covers the total cost for banner manufacturing, installation and removal. If approved, a contribution agreement outlining the terms of the sponsorship will be developed with Steveston Judo Club.


Conclusion


Staff recommends supporting the street banner sponsorship initiative as proposed by Steveston Judo Club. The proposed display of banners in Steveston would both celebrate the Japanese heritage in Steveston and help the club recognize its 50th Anniversary.


