Priorities for New Product Stewardship Programs

Approved

The GVS&DD Board will recommend to the Minister of Environment that the following product categories be considered as immediate priorities for new product stewardship programs:

- o Electronics not included in the existing Recycling Regulation
- Large and Small Appliances
- Pesticides not included in the existing Recycling Regulation
- Mercury-containing Products
- o Dry Cell Batteries (Rechargeable and Non-Rechargeable)
- Gypsum/Drywall

The Board further directed staff to convene a GVRD-led symposium on packaging and printed paper as a first step towards establishing product stewardship programs for these materials, including stewardship programs and the use of biodegradable alternatives to packaging materials such as plastic bags.

GVRD Regional Chlorofluorocarbon (CFC) Recovery Program

REPORTS FROM COMMITTEE OR STAFF

Road Pricing: An Overview of Current Practice

Approved

The GVRD Board requested that staff stage a special session of the GVRD Sustainability Dialogues to discuss road pricing and other transportation demand management methods that may be applicable to Greater Vancouver and the conditions that would be necessary to warrant implementation of road pricing in the future. The Board will invite the TransLink Board and the appropriate provincial and federal government ministries to collaborate with the GVRD on hosting the Dialogue on Road Pricing and other Transportation Demand Management (TDM) options. The Board further directed staff to arrange a meeting with Provincial, Federal and Lower Mainland officials to discuss how the GVRD can support senior government directions on global warming and greenhouse gas emissions.

Fisheries Issues on Capilano River

Approved

The GVRD Board and the GVWD Board will address the issue of high mortality of salmonid smolts migrating over Cleveland Dam on the Capilano River which was brought to the Environment Committee's and Water Committee's attention. Emission Impacts of the Transit System

Approved

The GVRD Board will include in GVRD comments on the new TransLink governance structure the recommendation that TransLink establish a system-wide decision making process, which includes a review of the resulting environmental impacts and health impacts, as one of the formal criteria in making future procurement decisions.

The Board will further request TransLink to provide a report on how environmental and health impacts of diesel fuel and natural gas emissions are incorporated in TransLink's fleet procurement decision-making.

Burns Bog Ecological Conservancy Area -- Management Plan

Approved

Future of the Region Sustainability Dialogues: Labour and Immigration – Labour Pains

Approved

The GVRD Board will forward the report dated May 2, 2007, titled "Future of the Region Sustainability Dialogues: Labour and Immigration – Labour Pains" to member municipalities, and other related agencies for their information and comment.

Emergency Planning for Electoral Area 'A'

Approved

The GVRD Board approved the following actions in regards to Emergency Planning for Electoral Area A:

- Direct staff to complete a Local Emergency Plan for Electoral Area 'A' in accordance with the requirements of the Emergency Program Act;
- Establish a GVRD Emergency Management Organization ("EMO") composed of the Chief Administrative Officer, the Deputy Chief Administrative Officer and the Managers of each department within the GVRD, for the purpose of implementing emergency plans and other preparedness, response and recovery measures for emergencies and disasters within Electoral Area 'A'; and
- Authorize and delegate to the EMO the power to cause all or part of the Local Emergency Plan for Electoral Area 'A' to be implemented, whether or not a state of local emergency has been declared, if in the opinion of

- the EMO, an emergency exists or appears imminent or a disaster has occurred or is threatened in all or part of Electoral Area 'A';
- In the event that a state of local emergency has been declared and is subsisting for all or part of Electoral Area 'A', the power to do all acts and implement all procedures that it considers necessary to prevent, respond to or alleviate the effects of that emergency or disaster within the affected areas of Electoral Area 'A', including any or all of the following:
 - A. acquire or use any land or personal property considered necessary to prevent, respond to or alleviate the effects of the emergency or disaster;
 - B. authorize or require any person to render assistance of a type that the person is qualified to provide or that otherwise is or may be required to prevent, respond to or alleviate the effects of the emergency or disaster;
 - C. control or prohibit travel to or from any or all of the affected areas of Electoral Area 'A':
 - D. provide for the restoration of essential facilities and the distribution of essential supplies and provide, maintain and coordinate emergency medical, welfare and other essential services in any part of the affected area of Electoral Area 'A';
 - E. cause the evacuation of persons and the removal of livestock, animals and personal property from any or all of the affected areas of Electoral Area 'A' or any area of Electoral Area 'A' that is or may be affected by an emergency or disaster and make arrangements for the adequate care and protection of those persons;
 - F. authorize the entry into any building or on any land, without warrant, by any person in the course of implementing an emergency plan or program or if otherwise considered by the EMO to be necessary to prevent, respond to or alleviate the effects of an emergency or disaster;
 - G. cause the demolition or removal of any trees, structures or crops if the demolition or removal is considered by the EMO to be necessary or appropriate in order to prevent, respond to or alleviate the effects of the emergency or disaster;
 - H. construct works considered by the EMO to be necessary or appropriate to prevent, respond to or alleviate the effects of the emergency or disaster;
 - I. procure, fix prices for or ration food, clothing, fuel, equipment, medical supplies or other essential supplies and the use of any property, services, resources or equipment within the affected areas of Electoral Area 'A' for the duration of the state of local emergency.

Dedication of Land as Regional Park GVRD Bylaw No. 1061, 2007

Adopted

The GVRD Board adopted "Greater Vancouver Regional District Dedication of Land as Regional Park Bylaw No. 1061, 2007".

OTHER BUSINESS

Changes to GVRD Appointments to External Agencies – 2007

Approved

The GVRD Board rescinded the resolution of the January 26, 2007 GVRD Board meeting appointing Scott Young as representative to the Municipal Finance Authority, the Fraser Basin Council and the Board of Trustees of the Sasamat Volunteer Fire Department, for 2007. They appointed Ralph Drew as representative to the Municipal Finance Authority for 2007 replacing Scott Young; Michael Wright as alternate representative to the Municipal Finance Authority 2007 replacing Ralph Drew; Richard Walton as representative to the Fraser Basin Council for 2007; and Michael Wright as representative to the Board of Trustees of the Sasamat Volunteer Fire Department for 2007.
