








Staff Report

Origin

The City's contract for residential solid waste and recycling collection services expires on December 31, 2007. Our current service provider is International Paper Industries (also known as Halton Recycling Ltd.).

A new tender for services was issued in May, 2007. This report presents the results of the tender process, and recommends award of the contract to Sierra Waste Services Ltd.

Analysis

A tender opening was held on June 19, 2007, at which the following three tenders were received:

The services, as tendered, are based upon current program arrangements.

Financial Impact

The tendered amount of the low bidder, Sierra Waste Services Ltd., is comparable with current costs paid for these services. These amounts are within anticipated budget expectations. This program is funded from the annual solid waste and recycling utility rates.

Conclusion

The tender proposed by Sierra Waste Services Ltd. represents best value to the City and is therefore recommended for award. The new contract will take effect January 1, 2008.
