4. **PROPOSED ACCESS IMPROVEMENTS AT THE PALMS DEVELOPMENT (7080 AND 7088 ST. ALBANS ROAD AND 8433 BENNETT ROAD)**

Donna Chan, Transportation Engineer, briefly reviewed the report.

Ms. Monica Stefansson, representative of the Strata Council of the Palms, and Mr. Dale Bosa, representative of the developer, were present.
