- 1. That staff be directed to send a letter to the Minister of Small Business, Tourism, and Culture informing the Ministry that the City of Richmond will not be submitting a formal bid for the BC Summer or BC Winter Games this year.
- 2. That staff be directed to annually review future organized games bids with participation from Sports Council to determine the overall level of community interest in the coordination of future games events for Richmond.

STAFF REPORT

ORIGIN

At the February 29th, 2000 Community Services Committee meeting, the following recommendation was approved:

"That Council direct staff to host a meeting of community members to determine interest in creating an ad-hoc committee to provide a co-ordinated approach when applying for and hosting games in the City of Richmond."

In May of 2000, the City of Richmond received an unsolicited letter from Ian Waddell, Minister of Small Business, Tourism, and Culture inviting Richmond to bid on the 2004 or 2006 BC Summer or Winter Games (Attachment 1). This report outlines a framework for discussion with community and business leaders regarding the possibility of the City pursuing future large-scale games bids. While all of the possible Games available for bidding have not been detailed, basic information is included for discussion. Staff have polled community representatives from Richmond sports groups and community members, and have received a positive response in regards to the formation of a committee to investigate the feasibility of pursuing future games bids for Richmond.

After receiving feedback from community leaders, the information detailed in this report may be used on an annual basis as part of a consultation process with community groups to prepare future recommendations to Council for future action. Staff are not recommending pursuing a games bid at this time.

ANALYSIS

History Of Organized Games Events Held In Richmond:

- 1979 BC Summer Games
- 1989 Canada Foresters Games for the Disabled
- 1990 Commonwealth Games Bid (unsuccessful games bid)

While there have been only two major provincial organized sport events held in Richmond over the past 21 years, comments from those involved in the organization and facilitation/bidding process for these games are detailed below:

Transportation Within Host Community:

It is usually the responsibility of the host community to transport participants throughout the community; complete financial assistance is usually available from the Games Society, except in the case of the Canada Senior's Games.

Marketing And Souvenir Sales:

The BC Games Society retains a contractor to provide official games souvenirs. The contractor works with the host community volunteers to maximise souvenir sales. Profits from Pre-Games and Games souvenir sales contribute to the financial legacy in each community. Revenue from 1991-2000 has ranged from \$352,000 (1991 Duncan/North Cowichan) to \$120,940 (2000 Quesnel).

Spending/Economic Indicators From Past Organized Games Events:

- The direct spending impact has ranged from \$1.3 to 3.7 million, depending on whether the Games are in summer or winter, and on the community size and its economic base. (Source: 2004 & 2006 BC Games Society Bid Package).
- Legacies have ranged for summer and winter games (BC) from \$79,000 to 280,000, average legacy 1990 to 1997 for both games is: \$186,400.

Sports Involved In Organized Games Events:

 As a general rule, up to 23 different sports can be held in summer/winter games events. Seniors Games have 20 events.

Timelines For Bid Processes:

- Canadian Senior's Games: February (2 years prior) Distribution of Bid Applications, July 30th (2 years prior) Bid Application Date, September 30th (2 years prior) Host Municipality selected and notified, October 30th (2 years prior) Hosting Agreement executed by CSGA.
- BC Summer/Winter Games: Now accepting bids for 2004 and 2006 Games events. Submission for these dates must be received by the BC Games Society prior to November 3, 2000.

Other Things To Consider:

Other significant things to consider in the organization of games bids include:

- Focus of resources for organized sport in Richmond is traditionally for youth.
- The accreditation and training of volunteers.
- T-shirt/hat/jacket/gym bag printing and distribution.
- Recognition event organization.
- Criminal record checks for volunteers.
- Impact to existing events and programs in the host city.
- Traffic problems (parking at venues).
- Signage in the community.
- Advertising and marketing.
- Media access and liaison(s).

- Catering for events.
- Misc. equipment: timers, scoreboards, tables, chairs.
- Some infrastructure is not available in Richmond (e.g. veledrome etc.)
- A major event would need to be incorporated into Parks Recreation and Culture Capital Budget and work program planning for targeted years.

FINANCIAL IMPACT

There is no financial impact at this time. Depending on the targeted year for any organized games bid, City budget requirements could range from \$40,000 to \$80,000 in addition to staff costs for the operation of a four day provincial games event.

CONCLUSION

While bid applications for the 2004 and 2006 BC Summer and BC winter Games will be accepted by the Ministry of Small Business, Tourism and Culture until November 3, 2000, staff do not recommend the submission of a bid from the City of Richmond at this time. The purpose of organized Games in BC, specifically the BC Summer and Winter games is to put the spotlight on BC's young people- to give them the opportunity to participate in the health and social benefits of sport.

Richmond has a history of placing an emphasis on the provision of facilities and programs to involve youth in both recreational and organized sporting activities. Due to the high level of community involvement required in the organization of a games event, in addition to existing civic programs and events, and the resulting low benefit of potential legacies from the provincial events in particular, staff do not recommend the pursuance of an organized games event in Richmond in the near future. With the assistance of the Richmond Sports Council and interested community members, staff can determine the overall level of community interest in future games events for Richmond on an annual basis.
