## Staff Report

### Origin

The provincial Liquor and Licencing Branch (LCLB) issues licences under authority of the Liquor Control and Licencing Act Regulations.

The LCLB notifies local government to give them the opportunity to provide comments and recommendations to the LCLB on all liquor licence applications.

This report will deal with the application from Mr. Eugene Ng, operator of the Wet Restaurant at unit 165 – 8460 Alexandra Road, who is requesting an extension of hours of operation Monday through Wednesday 11 a.m. to 1 a.m., Thursday through Saturday 11 a.m. to 2 a.m. and Sunday 11 a.m. to 1 a.m.

### Analysis

Wet Restaurant has applied to the Province to extend their hours of operations Monday through Wednesday 11 a.m. to 1 a.m., Thursday through Saturday 11 a.m. to 2 a.m. and Sunday 11 a.m. to 1 a.m. Although the applicant has requested an extension to the hours of operation regarding Sunday from 11 a.m. to 1 a.m., staff have made him aware that a Sunday 1 a.m. closing would not be supported. Staff have reviewed other businesses operating in the area and could only support Sunday from 11 a.m. to midnight in order to be consistent with the status quo. Wet Restaurant is zoned Automobile-Oriented Commercial District (C6).

The provincial Liquor Licensing process requires the City to provide resolution based on the comments received from residents and agencies in the City in the following areas:

- The potential for noise
- Impact on the community
- Views of the residents

The public process required the posting of a sign notifying the public of the application for a minimum of thirty days; three advertisements placed in the local paper and letters sent to residents within 50 metres of the establishment requesting their comments on the extension of hours for Wet Restaurant. The thirty-day time frame has lapsed.

The Wet Restaurant is located on Alexandra Road zoned Automobile-Oriented District (C-6), all of the properties adjacent to this site are zoned C6.

Since the introduction of the new Provincial Liquor Regulations, Council has expressed a strong concern against extension of hours beyond 2:00 a.m. for liquor establishments in Richmond. Research from the City of Vancouver shows the additional costs and the impact extended hours has on staff resources. These costs are born by the city when hours are extended to establishments.

Staff have taken the RCMP comments; the location of this establishment and the hours of other restaurant establishments into consideration and see no impact for noise or negative impact on the community should the hours be extended. Staff recommends that the Wet Restaurant be considered for extension of hours Monday through Wednesday 11 a.m. to 1 a.m., Thursday through Saturday 11 a.m. to 2 a.m. and Sunday 11 a.m. to midnight. There appears to be no negative responses from any of the other agencies, business owners or the residents in the area to this request.

### Financial Impact

None at this time.

**Conclusion**

Staff have reviewed all necessary reviews and recommend Council extend the hours of operation for the Wet Restaurant at unit 165 – 8460 Alexandra Road from the current hours of operation Monday to Sunday 11 a.m. to Midnight to the proposed new hours of Monday to Wednesday 11 a.m. to 1 a.m., Thursday through Saturday 11 a.m. to 2 a.m. and Sunday 11 a.m. to midnight.
