The original date of September 4th had been changed a couple of times and somehow Oct 4th instead of Oct 1st stuck in my mind.

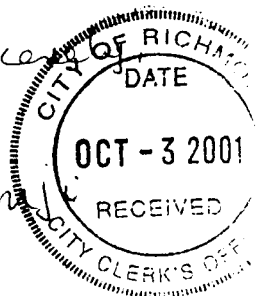
Would you please allow me to attend the next meeting which I understand is on October 15th, 2001.

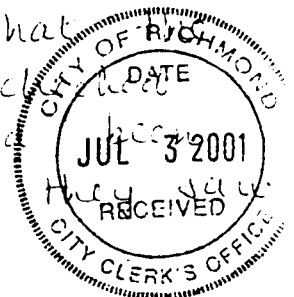
