**Business Plan for Safe Communities Foundation**

- Discussion ensued regarding the Business Plan Table of contents. Comments included:
  - Item 4 to be linked with Item 5;
  - Add information on Street Racing and the Safety Village;
  - Homesafe program to be a first initiative;
  - Build the survey as an appendix to the business plan;
  - Grow ops to be added as an initiative
  - A working group could be created to devise information for each item; contact WCB, School Board, Hospital
  - To be presented to Committee for input and review; may want to proceed with any specific initiatives from each groups point of view
- Mary Campbell to advise Mary Brunet of contact information for the Richmond Injury Prevention Network; also to advise the group with information on the WCB Certificate for youth

### **CSATF Surveys**

- The form was discussed, with some comments made – grow ops requires more attention; didn't get the response had expected from the Asian community – does not reflect the City; change focus areas to youth, Street Racing and traffic safety issues; educate the parents; contact groups such as RAPA, SUCCESS, Asian groups, Intercultural Advisory Committee; add survey to internet
