




**Origin**

Council approval for the following discharge of right of way is required:

- Property Affected:** 11000 No. 5 Road
- Right of Way to be D/C:** Left over portion of a right of way for public access, put into place under previous lot configuration which anticipated a future lane. Plan LMP44577 Charge No. BP1089.
- Reason for Discharge:** Right of Way charge carried over to newly consolidated parcel in error. Discharge will enable placement of garbage/recycling enclosure, per development permit design.
- Financial Implications:** No cost to the City.
- Legal Description:** Lot A Section 6 Block 3 North Range 5 West New Westminster District Plan BCP19064.






