Update on Meeting with Dawn Vallet (Safe Communities Foundation)

Kari distributed a revised copy of the Draft Business Plan (Safe Communities Foundation application), and advised that the target presentation date to the Foundation was April\May, 2004. A steering committee would shortly be formed, comprising representation from WCB, Richmond Health Services, YVR, and the School District with the Task Force group also potential members. A list of community sponsors would also be created, plus development of a liaison involvement with other organizations.

It was suggested that the word "Foundation" implied a charitable organization; would "Coalition" be preferable for this non-profit participation status. (Kari left meeting at 5:55pm).

Presentations to Community Groups

The group believed that information generated from the survey handed out at community group presentations had proved valuable, with traffic safety (not restricted to street racing concerns) appearing to be an issue with the community. In response to a concern expressed that only 69 surveys had been completed, and was that reflective of a cross-section of the community, the Chair advised that, although not a large response, it echoed the poss Reid survey, and the benefit gained from information received was apparent.

Following the suggestion that groups specifically having Asian membership be contacted for their input, it was advised that past meeting notes had outlined Task Force members who were assigned to contact various groups, however, not all outlined organizations had been contacted.
