Staff Report

Origin

At the November 29, 2007 Finance Committee, as part of a review of the 2008 Capital Budget, staff were requested to provide an update on the status of Council's commitments and potential funding sources for building two artificial turf fields within 2008. The resolutions from Deccember 19, 2005 and July 9, 2007 are included as Attachment 1.

The purpose of this report is in response to that request.

Analysis

Richmond is currently home to three artificial turf field sites, Minoru field constructed in 2002, Richmond Secondary in 2005, and Hugh Boyd in 2006, all totalling 5 fields in size. Since approval of the Richmond Soccer Alliance proposal by Council in December 2005, two reports have primarily guided the process.

December 2005 to September 2006

In December 2005, staff sought approval of the Richmond Soccer Alliance proposal for the installation of 4 artificial turf fields by 2008. A comprehensive site selection process, financial impacts, and a proposed timeline for field construction were included.

The outcome of this report was significant, including the design and construction of the \$2.95 million Hugh Boyd turf field, equivalent to three full sized fields, the largest in North America, and the introduction of field user fees on all of Richmond's fields.

In addition, a \$250,000 contribution was received for the project from the Richmond Soccer associations, three baseball facilities were developed, a low income player access program was initiated, and a field sport strategy was developed with the vision for Richmond to create a place where Everyone Can Play.

Council directed staff to identify locations for two additional fields, and to report back with options. At that time, it was noted that Council could not commit funding for future capital programs, and that funding would be dependent on annual civic priorities.

In the report, staff clearly identified that it was not a typical City procedure to commit capital funding before approval of a future year's capital plan. The only mechanism to identify future projects was to prepare a capital submission for consideration in the 5-year capital plan in order to complete Phase 2. As part of the 5-year capital budgeting process, \$3,500,000 was submitted to the 2008 capital program to complete the second two field projects.

The table below outlines the direction from Richmond City Council, the action taken, and the status of each resolution.

Phase 2 - September 2006 to Present

Since September 2006, staff worked with the field sport community, and undertook an analysis of potential field configurations that would realise the Richmond Soccer Alliance proposal, and have the greatest overall community benefit. King George Park location was identified and approved for consideration in the 2008 Capital Budget and the other location was subject to additional public consultation and new funding of up to \$3.5 million dollars.

The two other possible locations considered are Minoru Oval and South Arm Park. Each of these required further study for staff to make a recommendation to Council. In order for an additional field to be completed in 2008, the funding will need to be committed prior to the decision on the final location.

During the 2008 capital budget process, available funding was identified at \$2.2 million dollars.

It should be noted that at the November 29th Finance Committee meeting, staff reported that Minoru Park, if selected, could be completed for an additional \$600,000, this field upgrade would not include required field lighting or installation of fencing, and staff does not recommend this option. If Minoru Field, or South Arm were to be selected, additional capital totalling \$1.3 million would be required.

Timing

Subject to approval of two artificial turf fields for 2008, the following timeline is proposed:

Financial Impact

The current proposed 2008 Capital program includes an allocation of \$2.2 million for artificial turf fields. Subject to Council approval, the financial impact for the construction of two fields in 2008 have an estimated total cost of between \$2.8 million and \$3.5 million. Consequently, a shortfall exists between \$.6 million and \$1.3 million. Staff are recommending that this be funded as follows:

- 1. \$2,200,000 as per the existing 2008 proposed Capital plan presented to Finance Committee on November 29th, 2007 and;
- 2. An additional amount of up to a maximum of \$1,300,000 from the Community Legacy and Land Replacement Reserve. However, the first \$1,300,000 in interest income earned on this Reserve in 2008 will go toward replenishment of this principal amount.

The operating budget impact for the two fields will be \$30,000 or 0.03% tax impact.

Conclusion

If two fields are approved for 2008 construction, additional capital would be required. Subject to the completion of the current South Arm Park field master planning process, and community consultation for Minoru, staff will report back to Council in March 2008 with a recommended implementation seenario.
