#### **Finance**

Draft Greater Vancouver Districts' 2006 Budget

APPROVED

The GVRD Board approved the 2006 Revenue and Expenditure Budgets, use of Reserves and changes to staffing level, as presented for Regional Parks, 911 Emergency Telephone Service, Air Quality, General Government, Strategic Planning, Labour Relations, and Electoral Area 'A'. It should be noted that Sasamat Volunteer Fire Department Schedule B12 was deferred.

# Draft Greater Vancouver Districts' 2006 Budget Schedules

**APPROVED** 

The GVRD Board approved the following changes made a the October 21 Special Meeting of the Board: \$20,000 for 'BC Agriculture in the Classroom; debris management funding at \$205,000 as a one time expenditure only; 5 year financial targets have been amended to reflect the adoption of the Parks and Greenways plan over a ten-year implementation period; and the Financial Planning Bylaw needed to support the 2006 Budget and the Five-Year Financial Targets.

• GVRD Geospatial Reference System Fees and Charges Bylaw No.1039, 2005

**APPROVED** 

The GVRD Board read a first, second and third time, reconsidered, passed and finally adopted the GVRD Geospatial Reference System Fees and Charges Bylaw No.1039, 2005.

# Corporate and Intergovernmental Reports

Policy Alternative for the Board and Committee Meeting Procedures

**APPROVED** 

The GVRD Board approved issues 2 through 12 relating to board and committee meeting procedures as outlined in the report dated October 2005 titled "Policy Alternatives for the Board and Committee Meeting Procedures." Issue 1, items i, ii, iii, were approved as written, and item for iv in the event of a tie vote of more than two candidates, the result of the election will be determined by preferential ballot system. The Board also requested that the province authorize the Board under the *Local Government Act* to approve the Chair's appointments to standing committees and authorize the board to establish standing committees. The Board referred the matter of committee members electing the committee chair to further review.

## Parks Reports

 Results of the Alternative Approval Process for Greater Vancouver Regional District Disposition of Part of Crippen Regional Park Bylaw No. 1031, 2005 and Proposed Sale of the Surplus Lands to Bowen Island Municipality **APPROVED** 

The GVRD Board reconsidered, passed and finally adopted Greater Vancouver Regional District Disposition of Part of Crippen Regional Park Bylaw No. 1031, 2005, and approved the sale of the surplus lands to Bowen Island Municipality for two million dollars, subject to the GVRD's Chief Administration Officer's approval of the final terms and conditions of the sale.

 Brae Island Management Plan: Preferred Concept, Policy and Program Framework for Park Management Plan and Implementation **APPROVED** 

The GVRD Board approved the Preferred Concept, Policy and Program Framework of the Brae Island Regional Park Management Plan and campground service delivery model. The Board also authorized staff to select a private campground operator.

## Planning and Environment Reports

## • Air Quality Management Plan

**APPROVED** 

The GVRD Board adopted the new Air Quality Management Plan for Greater Vancouver dated September 27, 2005 and requested that the Plan be forwarded to the member municipalities, the Medical health officers for Greater Vancouver, the Provincial Minster of Environment, the Federal Minister of Environment, First Nations, the Fraser Valley Regional District Board, the Northwest Clean Air Agency Board, and other key stakeholders indicating the Board's continuing interest in working with them on improving air quality in the Lower Fraser Valley.

## • Implementation of the Air Quality Management Plan

**APPROVED** 

The GVRD Board directed staff to proceed with implementation of the *Air Quality Management Plan for Greater Vancouver* based on the priority actions set out in the report titled "Implementation of the Air Quality Management Plan", dated September 27, 2005.

# • Corporation of Delta Regional Context Statement

**APPROVED** 

The Board directed accepted the proposed Regional Context Statement for the Corporation of Delta as contained in the Official Community Plan 2005, Bylaw No. 6350 and Bylaw No. 6400.

# • Compliance of South Campus Northeast Sub-Area Neighbourhood Plan with the Official Community Plan for UBC

**APPROVED** 

The Board acknowledged the compliance of UBC Neighbourhood Plan for the South Campus area with the Official Community Plan (OCP) and confirmed that in the event of a conflict in interpretation between the South Campus Northeast Sub-Area and the OCP, the OCP will take precedence. The Board also recommended that UBC amend the UBC Comprehensive Community Plan to reflect the South Campus Northeast Sub-Area Neighbourhood Plan to ensure its compliance with the OCP for UBC.

# Buntzen Bay, Indian Arm – Notice of Building Bylaw Contravention Progress

**APPROVED** 

The GVS&DD Board authorized the expenditure of up to \$1.2 million of budgeted capital funds for replacement of the Chilco Force Main.

## Powell River Regional District (PRRD) – Waste Disposal Agreement Renewal

**APPROVED** 

The GVS&DD Board authorized the Commissioner to renew the existing GVS&DD/Powell River District Agreement for Waste Disposal as Cache Creek for one year to March 1, 2007 with an option to extend to December 31, 2008, the anticipated closure date of Cache Creek Landfill, subject to necessary approvals being obtained by PRRD from the Thompson-Nicola Regional District and the Village of Cache Creek.

• Draft Greater Vancouver Districts' 2006 Budget

APPROVED

The GVS&DD Board approved the 2006 Revenue and Expenditure Budgets, use of Reserves, changes to staffing levels of the Greater Vancouver Districts' Budgets, and Capital Expenditures. The Board also set the Water Rate for 2006 at \$0.2908 per cubic metre.

• 2005 Payment in Lieu of Property Taxes

APPROVED

The GVWD Board approved the payment of a grant in lieu of taxes to member municipalities totaling approximately \$1,000,000 and requested the Province of BC allow the 2005 payment as a grant in lieu of property taxes.

Cleveland Dam Hydroelectric Power Generation Potential

**APPROVED** 

The GVWD Board will request the Province to revise the GVWD Act to allow the GVWD to sell power and, if and when this is achieved, staff could explore the environmental, regulatory, policy and financial issues associated with developing hydroelectric power generation capability at Cleveland Dam.

# Coquitlam Ozone Disinfection Facility – Backup Chlorine Disinfection System and Liquid Oxygen Storage Tank

**APPROVED** 

The GVWD Board authorized the expenditure of up to \$1.2 million of budgeted capital funds for construction of a replacement backup chlorine disinfection system and a second liquid oxygen storage tank for the Coquitlam Ozone Disinfection Facility.
