# Staff Report

## Origin

Richmond Fire-Rescue (RFR) is committed to keeping Council informed of its activities on a quarterly basis.

# Analysis

Below is Fire-Rescue's 3rd Quarter report for July 1 to September 30, 2010.

# Suppression Activity

Fire Suppression's 9-1-1 emergency call volumes for the 3<sup>rd</sup> Quarter of 2010 are presented in the table below. Subsequent tables provide details on calls types by: fires and estimated loss; medical; and hazmat.

The quarterly call volumes fluctuate from year-to-year and can be influenced by variables such as extreme weather conditions (wind storms, heat waves, cold snaps or the presence of ice, snow, or heavy rain). In Q3 of 2010 cooler temperatures resulted in a 12% reduction in "fire" type calls as compared to the same Quarter in 2009. The continued reduction in "false alarm" type calls of 11.5% is attributed to the Fire Prevention Officers who work with repeat alarms locations to ensure improved on-site management of their fire alarm systems.

## Call Type Legend:

Medical includes: cardiac arrest, emergency response, home or industrial accidents

False Alarm includes: intrusion/security alarms; malicious; mistaken by equipment-smoke, dust, and/or steam

Alarm No Fire includes: accidental, malicious, equipment malfunctions

Public Service includes: assisting public, ambulance or police, locked in/out, special events, trapped in elevator, water removal

Public Hazard includes: aircraft emergency, bomb removal standby, object removal, or power lines down

Hazardous Materials includes fuel or vapour: spills, leaks, or containment

Explosion includes ruptured: boilers, gas pipes, or water pipes

Technical Rescue includes: aircraft, confined space, high angle, or water


# Community Response

Details of the 3<sup>rd</sup> Quarter's overall community response is detailed in the following tables. The estimated building loss for this quarter is \$843,575 and represents 1.4% of the total potential loss of \$61,042,915. The estimated content loss for this quarter is \$122,500 and represents .5% of the of the total potential loss of \$24,930,300.

#### Incidents

Notable emergency incidents which involved RFR for this quarter follow.

#### Rescue

- Assisted BCAS with a medical call and transport to Richmond General hospital involving a four person illegal drug overdose.
- Fire crews discovered a meth lab distribution centre 7800 Block No. 3 Road
- Single MVI into power pole on Westminster Hwy causing downed pole and road closure
- Attended a double pool drowning (unconscious) in 6300 Block of Minoru Blvd
- · Assisted RCMP with emergency decontamination for meth lab
- Single MVI with inverted car in a large ditch in the 22,000 Block of River Rd two
  patients with minor injuries.
- Motor vehicle launched approx. 55' over the Fraser River dyke at the north end of No. 1 Road. The vehicle containing two occupants ended up nose first in the marshy tidal area.

#### Fires - General

- Numerous summer seasonal fires include: bark mulch, vegetation, rubbish and beach fires at numerous locations.
- Car fire 8300 block of Capstan Way; boat fire Trites Road, life cart electrical fire Jericho Road.

# Fires - Residential / Single-Family

• Fire at a home under construction and in the lock up stage in the 10,000 Block Aintree.

## Fires - Residential / Multi-Family

 Apartment fire in a 3 storey wood framed building in the 8500 Block Westminster Hwy with one fatality. Occupants evacuated with over 30 being rescued from their balconies.
 Vancouver Fire provided mutual aid coverage in Richmond.

#### Fires - Commercial/Industrial/Institutional

 Structural fire in a cafe in the 4800 Block of No. 3 Road. Light smoke detected in the interior - thermal imaging cameras used to locate the fire on the building exterior under the building overhang.

### Awards

On June 22, 2010, a committee comprised of representatives from the Canadian Association of Fire Chiefs, the Emergency Medical Services Chiefs of Canada, the Canadian Association of Chiefs of Police met and decided that the City of Richmond, Gold Exercise be awarded the CACP/Motorolla Award for Excellence in Emergency Preparedness in the exercise category. Many staff worked tirelessly in planning the exercise, with the plan being executed with precision, purpose and professionalism. The successful delivery of the Gold exercise speaks to the positive partnership that exists between Richmond's emergency responders: BCAS, RCMP, DND, CGRU and the Coast Guard.

# Training

The training staff in RFR deliver training programs to all members of RFR in disciplines ranging from: Personal Protective Equipment, Firefighting and Rescue to Emergency Vehicle Operating and Incident Management. Training also delivers leadership and people skills programs through in-house instructors, on-line training, and the use of external trainers. For the 3<sup>rd</sup> Quarter the following highlights are noted:

## THARR

Major training evolutions for the new fire fighter recruits - utilizing the smoke tower at the new Shellmont Fire Hall.

Employee courses on "coaching for success" and employee evaluations. Water Rescue Program

# Recruit Training

 Completion of recruit training program for 4 new hires. The recruits now move onto shift to complete their probationary training, which continues for a further 8 months.

# Community Partnerships

- Richmond Fire-Rescue and the RCMP continue to work together on arson related activities such as streamlining of investigations and sharing of information. In July, two juvenile fire setters agreed to undergo counselling.
- 57 Annual fire drills for public schools.

The Steveston fire hall construction project is progressing with an estimated possession date of mid February 2011. The public opening will follow in late spring or early summer. This innovative use of pine beetle wood in the fire hall's construction has drawn the attention of Industry Canada who held a major tour of the site mid October.
