Staff Report

Origin

Council Policy No. 5017 states that the City Clerk shall forward to Council any Zoning or Official Community Plan Amendment Bylaw where one year or more has elapsed from the conclusion of the relevant Public Hearing with a recommendation to abandon the bylaw; to require another Public Hearing if the bylaw is not to be abandoned; or another recommendation if warranted. Although the review of outstanding bylaws is largely considered a "housekeeping task", this year the process was particularly significant in order to clear such bylaws "off the books" in anticipation of the new Zoning Bylaw coming forward to Council for consideration.

Analysis

Upon reviewing the OCP and Zoning Bylaws which have been to a Public Hearing but have not yet been adopted, planning staff identified a number of applications that are several years old and have had little or no activity since their respective Public Hearings. In some instances, applications have been withdrawn but the bylaws have not been officially abandoned. A letter was provided to each applicant requesting that they advise staff of their intentions with respect to the outstanding bylaw. The results of this survey indicates, generally, that applicants expressed no objection to their respective bylaw being abandoned, or the applicant specifically does not wish to proceed with their application. In some cases, the contact information held on file was found to be no longer current. Attachment 1 to this report provides the relevant status of each bylaw and the circumstances associated with the bylaws being recommended for abandonment.

Financial Impact

None.

Conclusion

Several unadopted Zoning Amendment Bylaws have been identified as no longer being required because the related application has been withdrawn; the applicant does not wish to proceed; or the applicant has not made contact with staff for the purpose of proceeding with the requirements of the application, for a number of years. Staff are, therefore, recommending that the bylaws be abandoned.
