The Council of the City of Richmond enacts as follows:

- 1. The lands legally described as Road dedicated by Plan 2171 Section 12 Block 3 North, Range 7 West, New Westminster District, shown outlined in bold on the Reference Plan prepared by K. M. Power, Surveyor, attached as Schedule A, shall be stopped up and closed to traffic, cease to be a public road and the road dedication shall be removed.
2. This Bylaw is cited as "Road Stopping Up and Closing Bylaw 9294".

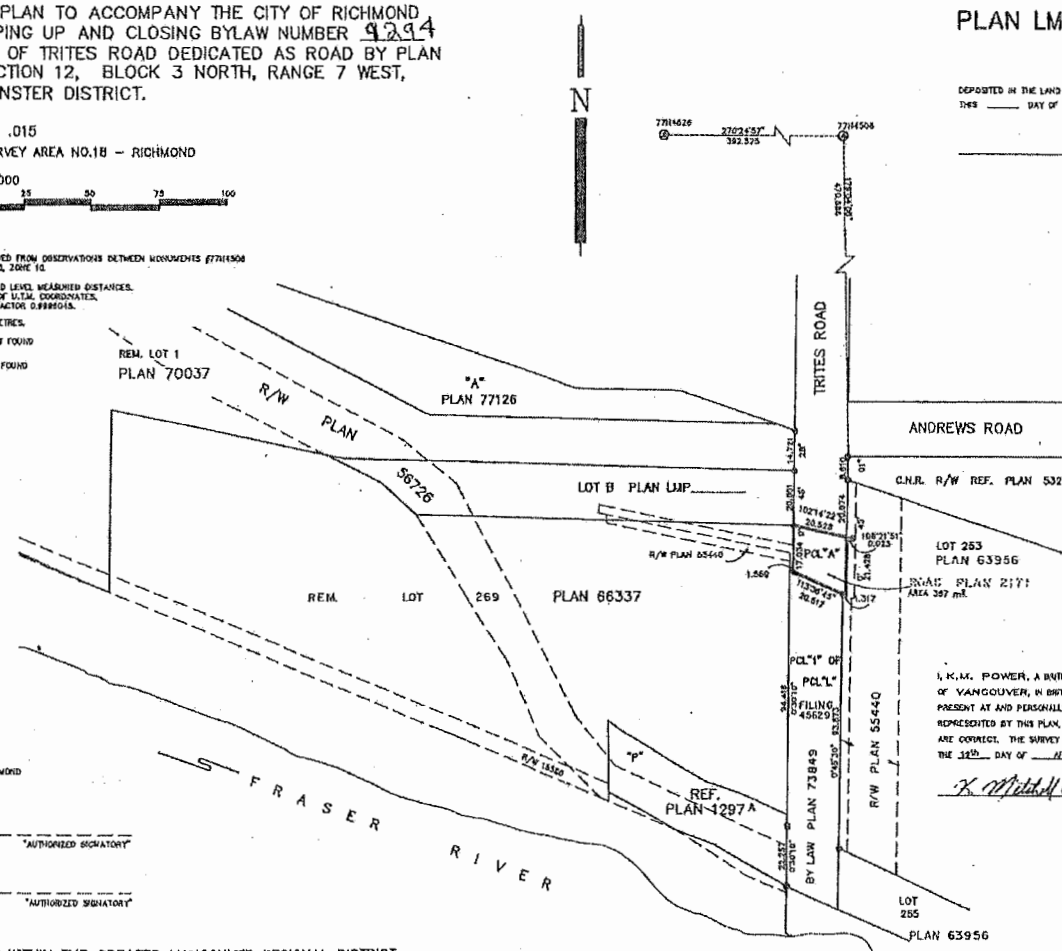
