- 1. The lands legally described as Road dedicated by Plan 17473 Section 32 Block 4 North Range 5 West New Westminster District, shown outlined in bold on the Reference Plan EPP47787 prepared by Matson Peck & Topliss, Surveyors and Engineers, with a control number of 142-265-4457, attached as Schedule A, shall be stopped up and closed to traffic, cease to be a public road and the road dedication shall be removed.
