Staff Report**Origin**

Pursuant to Section 168 (1) of the Community Charter, the total remuneration, benefits and expenses incurred by each member of Council must be reported annually.

Analysis

Total remuneration paid to Council members for the year 2008 was \$447,920 and cost of benefits was \$61,057. Total expenses incurred were \$31,566. The schedule below provides a summary for each Council member.


