## Staff Report

## Origin

The Officer In Charge of the Richmond RCMP Detachment acknowledges and supports that the City of Richmond should be kept informed on matters pertaining to policing in the community and has developed a framework to provide regular reporting cycles.

## **Analysis**

Below is the RCMP's Monthly Activity Report for August 2009.

## Station Targeted Area Response (STAR) Team

On August 18, 2009 the Canada Line rapid transit system became operational, connecting Vancouver with Central Richmond and the Vancouver International Airport.

The presence of uniformed police officers, made up of the Richmond RCMP Detachment's (STAR) Team working in partnership with South Coast British Columbia Transportation Authority Police Service (SCBCTAPS) is an initiative that will most certainly assist to minimize the crime profile near the Richmond stations.

The mandate of the STAR Team will be responsible to monitor and review crime trends provided by the Richmond RCMP Crime Analysts as they relate to the Canada Line and, if there is an identified trend, to target enforcement with potential assistance from SCBCTAPS or other Richmond RCMP units such as General Duty, Bikes, Plain Clothes, Serious Crimes etc.

The Star Team will also foster partnerships with volunteer groups and other Canada Line agencies for the benefit and safety of its Canada Line users and neighbours.

### Booze Can Bust - Recent Court Disposition.

The Richmond RCMP, with City staff, attended K Square Karaoke located at 220, 4351 – No 3 Road on three separate occasions in the summer of 2008. This is a karaoke establishment without a liquor licence. This investigation was initiated as a result of public complaints as well as previous police inspections.

On June 18<sup>th</sup>, 2009, the owner, Simon Leung, pled guilty in Richmond Provincial court to "Did unlawfully change the use of a building", contrary to Section 2.2.1(b) of the Building Regulation Bylaw.

A fine of \$8,000 was imposed along with the forfeiture of all the liquor seized.

## **Business Watch Blitz**

On June 18<sup>th</sup>, 2009 the Richmond RCMP Crime Prevention Unit organized a Business Watch Blitz in an effort to raise business security awareness. Richmond Crime Prevention officers,

staff, volunteers and auxiliary constables visited merchants throughout the City of Richmond and provided information on business security and crime prevention techniques.

The City of Richmond RCMP Business Watch Program aims to enhance communications between the police and the business community and to educate businesses in long-term crime prevention strategies in order to reduce crime.

Merchants received an information package including a height strip sticker that is installed in the main entrance doorway to assist with identification of suspects, a business security tips information sheet, and a Richmond Business Watch Program brochure.

## Robbery at a Richmond Home

Just before midnight on July 23rd, the Richmond RCMP received a 911 call from a distraught female calling from her home in the 3700 block of River Road. It was initially thought that RCMP members were attending a domestic but upon scene attendance it was determined that we were dealing with a robbery type situation.

Police arrived on scene and noticed several men fleeing in all different directions. Containment was quickly established and three of the men were apprehended.

The female victim did not sustain any injuries. The male victim sustained minor injuries. They are not known to police. This was a collective effort between Richmond General Duty members, Bike Section, Lower Mainland Emergency Response Team, Air 1, Police Dog Service and Deas Island Highway Patrol

## **Community Policing Section**

### Auxiliary Program:

Currently Richmond Detachment boasts 33 dedicated Auxiliary Constables who, to date in 2009, have volunteered a total of 2000 hours serving the community of Richmond. June and July were busy for the Auxiliaries as the coordinator has scheduled 13 events for the auxiliaries to take part in during the summer months.

The new Auxiliary troop is scheduled to be starting on September 9, 2009. Over 70 applicants applied for the 20 open positions. Over the next 4 months the new Auxiliary Constables will be taking various courses on policing, law, drill, self defence and use of force.

#### Crime Watch

The Richmond Citizens Crime Watch is currently accepting applications from members of the community interested in volunteering their time to make the community a safer place to live, work and play.

Richmond Citizens Crime Watch Volunteers contribute to the safety and well-being of the community by volunteering a minimum of five hours per month. Volunteers assist police, ICBC and the City by observing and reporting suspicious activities while making vehicle patrols.

The primary objective is to reduce criminal activity in Richmond including auto crime, criminal driving behavior, commercial and residential crimes, metal and wire thefts, parking meter thefts and vandalism. The program also aims to promote public awareness, safety and community involvement.

In partnership with the Insurance Corporation of British Columbia, Crime Watch members utilize the Stolen Auto Recovery System during patrols and at ICBC Counter Attack Road Checks. Volunteers are equipped with laptop computers loaded with an up-to-date list of stolen vehicle information.

The program is utilized by Citizens Patrol groups throughout BC and has become a tremendous success.

\*Patrols take place on Friday and Saturday nights\*

Qualification for the program:

- Must live, work or attend school in Richmond
- 19 years of age or older
- Submit to a criminal record check
- Commit to a minimum of one patrol shift (approximately 5 hours) per month\*

### NOTES .

Beginning in August 2009, the method of calculating monthly statistics will change slightly due to the
introduction of the Canada Line on August 17, 2009, and the fact that data from both Richmond RCMP
and Transit Police will be included in future reports. Individual offence totals will remain consistent, but
there will be changes in the UCR Category totals: some offences currently tallied under Other Criminal
Code will move to the Violent Crime or Property Crime categories.
