Staff Report

Origin

Business Licence fees are established by Council in Business Licence Bylaw 7360. As per the Long Term Financial Management Strategy (LTFMS), and in keeping with Policy 9 of the (LTFMS), all user fees are to be increased annually to keep up with inflation.

Analysis


For the licence year 2008, Council approved a fee increase of 2%. For the licence year beginning January 1, 2009, staff are again recommending an increase of 2%, rounding to the nearest whole dollar.

Financial Impact

Based on the number of licences issued in 2008, and with the proposed increase of 2%, approximately \$54,000 in additional fees could be expected.

Conclusion

The inflationary costs of administering the licence bylaw and an increase in enforcement costs, would indicate that the proposed increase is warranted. Further, the increase would be in accordance with Policy 9 of the Long Term Financial Management Strategy Policy whereby user fees are to be increased to keep up with inflation.

Business Licence Bylaw No. 7360 Amendment Bylaw 8443

The Council of the City of Richmond enacts as follows:

1. Each Vehicle for Hire **applicant** must pay:

- (a) an office licence fee of \$116; and
- (b) the following per vehicle Licence Fee, based on number of vehicles:

CLASS "C" Sightseeing Taxicab	\$106
CLASS "D" Airport Taxicab	\$106

- 3. The fee for transferring a Vehicle for Hire Licence within any calendar year is \$40
- 4. The fee for replacing a Vehicle for Hire Licence plate or decal is \$12

SCHEDULE B to BYLAW NO. 7360

1. The fee for transferring a licence from one person to another, or for issuing a new licence because of a change in information on the face of such licence, except a change between licence categories or subcategories, is \$40.
2. The fee for changing the category or subcategory of a licence is either:
 - (a) \$40; or
 - (b) the difference between the existing **licence** fee and the fee for the proposed category or subcategory,
whichever is the greater.
3. The fee for a Business Licence reprint is \$10.00.
