#### **Staff Report**

#### Origin

The School Community Connections Program was developed in 2005 to encourage partnerships between schools and local governments to greater utilize school facilities for broader community purposes. Richmond was successful in receiving funding in earlier rounds of this program to enhance facilities in the common area shared by Hamilton Elementary School and the Hamilton Community Association and to improve public access and use of this space.

The 2008 "Strengthening the Connection" program has been designed to provide modest grants to address local issues and provide direct benefit to students, their families and the community. Applications for this funding are due no later than October 30 2008. Eligible projects must support the program goals and objectives:

- To encourage and facilitate the co-location of services for students, their families and the larger community within school facilities;
- To make greater utilization of available or new school facilities; and
- To encourage collaborative, long-term facilities planning that takes into account the needs of the community as a whole.

The maximum grant available is \$8,000 for direct costs incurred in the development or implementation of the approved project. Ongoing operational costs are not eligible.

#### **Analysis**

Community gardens are important element of community building and food security for the City of Richmond. Currently, there are three City-owned community gardens with a total of 157 active plots. There is a waiting list of over 100 individuals who are interested in obtaining a plot.

Since the Spring of 2008, the City and the School District have been working with Evergreen, a national non-profit organization, to identify opportunities for a Community School Food garden.

School grounds are a natural fit for community gardens because they are public greenspaces which are well-located within neighbourhoods and, particularly within the urban core, are surrounded by higher density housing. Growing food on school grounds presents an opportunity to benefit students through learning about food from seed to table. However, one of the biggest challenges facing school gardens is in the summer months when students are out of school. The gardens require maintenance and can be plagued by vandalism. By creating shared food gardens, these challenges can be overcome and the community can benefit by additional available community garden plots available during the summer months.

Richmond Secondary already has a small, active food garden. It is an ideal location to pilot a Community School Food garden as it is well-situated near Richmond Centre, has enthusiastic staff and teachers, is walking distance of several City facilities including the Minoru Seniors Centre and the Cultural Centre and there is available space to expand the existing garden.

Costs associated with this project will be related to construction of the garden as well as communication and educational materials and a Garden Coordinator to assist both the school and the community element of the garden (att. 1). Evergreen is working with the School District and the City to identify a number of potential sources of funding (att.2) including the School Community Connections Program Grant. It is anticipated that some administration costs would be incurred by the City in opening up additional community garden plots but that these costs would be absorbed within the existing Parks operating budget.

#### Financial Impact

There is no financial impact of applying for the School Community Connections funding.

#### Conclusion

The City of Richmond and Richmond School District have a long history of joint use of parks for the benefit of the community as a whole. The School Community Connections "Strengthening the Connections" grant provides an opportunity to extend this relationship to Community Gardens.

### 4.5 Budget



Funding for this demonstration project will be provided through grants administered through Evergreen. Partners may provide cash, or in-kind support through additional grants. Once the project has been approved, fundraising will begin in earnest. Some seed money has already been secured and other potential funders have been identified below.

The most significant expense is attributed to supporting a part time garden coordinator. The number of days allocated can be broken down into half days, more frequently distributed, depending on the needs of the school and community.
