**Truck Parking Pilot Program - Bylaw Amendments** 

At the General Purposes Committee meeting of October 20, 2025, the Committee considered the report titled "Proposed Amendments to Traffic Bylaw 5870 and Consolidated Fees Bylaw No. 8636 for Commercial Truck Parking", dated October 14, 2025, from the Director, Transportation.

Discussion at the meeting ensued regarding priority for trucks registered in Richmond. This memorandum responds to this matter.

City bylaw amendments are required to facilitate the Council approved Truck Parking Pilot Program. Attached are the revised recommended amendments to the Traffic Bylaw No. 5870, Amendment No. 10703 and Consolidated Fees Bylaw No. 8636, Amendment No. 10720 to include a requirement for commercial trucks participating in the pilot program to be registered to Richmond owners and operators. Information regarding the registration criteria and priority for Richmond based commercial trucks will be included as part of the communications plan for the pilot program.

These bylaws supersede the bylaws in the staff report.

## Traffic Bylaw No. 5870 Amendment Bylaw No. 10703

The Council of the City of Richmond enacts as follows:

- 1. Traffic Bylaw No. 5870, as amended, is further amended by:
  - a. Removing and replacing, in its entirety, Section 12.8 with the following:

"No person shall park a commercial vehicle, or combination of vehicles, between the hours of 7:00 p.m. and 7:00 a.m. of the following day on any highway, unless otherwise permitted by the placement of traffic signs and registration of the commercial vehicle with the City. Registration of commercial vehicles is restricted to Richmond based owners or operators."

## Consolidated Fees Bylaw No. 8636 Amendment Bylaw No. 10720

The Council of the City of Richmond enacts as follows:

- 1. Consolidated Fees Bylaw No. 8636, as amended, is further amended by:
  - a. By adding to SCHEDULE TRAFFIC, Parking fees, Section 12B.1, 12B.4 with the following immediately below the Parking Permit Decal section.

Description	Fee
Commercial Truck Parking Zones	For dedicated truck parking spaces as identified in Traffic Bylaw 5870, the following fees are applicable:
	\$110.50 per calendar month, plus applicable taxes - Small commercial trucks less than 12 metres in total length.
	\$165.75 per calendar month, plus applicable taxes - Large commercial trucks greater than 12 metres in total length.
