

Subject: Minoru Senior Centre Expansion

We are concerned that there has been no concrete progress in plans developed to expand our centre so we can meet the growing needs of the 55 plus segment of our community. For more than 10 years we have been receiving assurances from our elected representatives and senior city staff that seniors are high on the priority list, only to learn time and again that we have been pre-empted by others, i.e. City Centre; new fire halls, new police station, etc. etc. We have been very patient thinking those in authority are aware of our needs and will develop a plan to ensure our expansion goes forward on a timely basis. When is this going to happen?

Representatives from the Minoru Seniors Society have participated in feasibility studies regarding our new building. We have yet to hear the status of this process.
