PRESENTATION

Jordan Oye, Chair, Richmond Public Library Board and Susan Walters, Chief Librarian, with the aid of a PowerPoint presentation (Copy on File, City Clerk's Office), presented the Library's 2021 Annual Report, and highlighted the following:

- the library welcomed over 440,000 visitors last year;
- the virtual library was a key resource for the community with 2.7 million visits;
- library fines were eliminated, providing equitable access to the community;
- over 36000 items were added to the library collection;
- employment programming was provided, connecting local hiring companies with over 550 people seeking job opportunities;
- in honour of National Day of Truth and Reconciliation, local Indigenous authors and artists were featured; and
- programs aimed at promoting and celebrating diversity in Richmond were offered during Black History month and Pride week.
