11. REFERRAL RESPONSE: TREE SURVIVAL SECURITIES

(File Ref. No. 12-8060-20-010715) (REDMS No. 8152467, 8158727, 8166208)

R25/18-6

It was moved and seconded

- (1) That the approved Pilot Program for On-Demand/Irrevocable Surety Bonds be extended to include Tree Survival Securities; and
- (2) That Tree Protection Bylaw No. 8057, Amendment Bylaw No. 10715, be introduced and given first, second and third readings.

The question on Resolution No. R25/18-6 was not called as discussion ensued regarding the tree survival security release flow chart.

As a result of the discussion, the following **amendment motion** was introduced:

R25/18-7

It was moved and seconded

That Tree Survival Securities continue to be released on a phased approach, with 90% of the security returned at substantial completion of construction upon submission of a Post-Construction Assessment Report, and the remaining 10% released one year later following the submission of a Final Post-Construction Assessment Report, rather than adopting the standardizing 100% release upon fulfillment of permit terms and conditions.

The question on Resolution No. R25/18-7 was not called as discussion ensued regarding (i) the timing of the securities release, (ii) surety bonds, and (iii) the responsibility of property owners and developers.

In response to queries from Council, staff advised that (i) further amendments to the Amendment Bylaw would have to be referred back for further review and (ii) new trees planted on site are covered under a separate security that is already subject to a 90% release with a 10% holdback.

Further discussion ensued regarding (i) new trees planted on site that are subject to Development Permit landscaping securities, which is separate from the motion on the table, (ii) the difference between a surety bond and security, (iii) significant trees, and (iv) retention of existing trees, remedial action for viable trees, and the Tree Protection Bylaw.

The question on Resolution No. R25/18-7 was then called and it was **DEFEATED** with Mayor Brodie and Cllrs. Au, Heed, Hobbs, Loo, and McNulty opposed.

The question on Resolution No. R25/18-6 was then called and it was **CARRIED** with Cllr. Wolfe opposed.

The following **amendment motion** was introduced:

That the City provide a helmet and lock with bikes provided to all other recipients of bikes under the Bike Reuse Program at a maximum cost of \$7,600.

The question on Resolution No. R25/18-10 was not called as discussion ensued regarding the costs associated with locks and helmets, in addition to the costs outlined in the report.

The question on Resolution No. R25/18-10 was then called and it was **CARRIED** with Cllrs. Day and Gillanders opposed.

The question on Resolution No. R25/18-8 as amended, which reads as follows:

That Option 3, as outlined in the report titled "Bike Reuse Pilot Program Review", dated September 19, 2025 from the Director, Public Works, amended to include City-provided locks and helmets to the recipients of bikes under the Bike Reuse Program, at a maximum cost of \$10,000, be approved.
