<u>Item No. 21 – Application by Sandhill Developments Ltd. for Rezoning at 5660, 5680 and 5700 Williams Road from Single Detached (RS1/E) to Two-Unit Dwelling (ZD5) – Steveston/Williams</u>

Dan Rusen, 10079 Lawson Drive, spoke in opposition to the application by explaining that high density locations create congestion and upset neighbourhoods. Mr. Rusen stated that he has been a Richmond resident for 14 years and has noticed an increasing number of condominiums and duplexes being built in the area over the past 7 years.

Further to his comments, Mr. Rusen disagreed with the description of the developments being labeled as "affordable housing" and felt that five hundred thousand dollars for a home is a large amount of money which could easily cause first time homebuyers problems should the interest rate increase. Mr. Rusen suggested that densification of homes in an area and other aspects of development, such as increased parking demand, should be reconsidered by the developers.

Schedule 1 to the Minutes of the Regular meeting of Richmond City Council held on Tuesday, May 24, 2015.

My name is Deirdre Whalen and I am here on behalf of the Richmond Poverty Response Committee. My colleague Trish Garner from the BC Poverty Reduction Coalition joins me this evening.

The Richmond PRC is a member of the BC Coalition and we together are requesting that Richmond City Council do two things:

- Endorse the Coalition's Open Letter on Poverty Reduction and,
- Approve and forward a Richmond resolution to the UBCM

The resolution before you urges the provincial government to adopt a comprehensive and accountable poverty reduction plan consistent with the recommendation of the Coalition.

The Richmond PRC has been actively involved in promoting the need for a poverty reduction plan. We have done this as a member of the RCSAC, which has presented eight submissions to Council from 2014-present (see Attachment 1). These issues are "canaries in a coal mine;" they tell a story of dire need in Richmond. Issues presented request that City Council urge the provincial government to improve situations for people experiencing poverty (such as bus pass increases, rent supplements and rent gaps, reductions in mental health funding, adult basic education fees, etc). The 2015 report "Municipal Responses to Child /Youth Poverty" details the need for a provincial poverty reduction plan with targets and timelines.

The Richmond PRC has also written to the provincial government to:

- Reverse child support payment clawbacks for mothers on income assistance and
- Urging the provincial government to adopt Bill 212 a Poverty Reduction and Economic Inclusion Act.

Richmond has done its homework. Poverty exists and is getting worse. With respect, Richmond City Council, the time has come to join other municipalities in BC and insist the provincial government act to establish a poverty reduction plan. BC is the only province without a plan. The Federal government has committed to work with provinces with a plan and institute processes to address housing, income security, food security, childcare, the major planks in a poverty reduction platform. I urge you to adopt the resolution for the UBCM.
