Staff Report

Origin

At the City Council meeting on September 13, 2004 approving the Terra Nova Rural Park Master Plan Council resolved:

"That the concept plan include Option 1 of part C – the complete ban of dogs at Terra Nova Rural Park."

This report addresses that resolution, and contributes to the Council term goal to "demonstrate leadership in and significant advancement of the City's agenda for sustainability through the development and implementation of a comprehensive strategy".

Analysis

The Council approved vision for the park is "to preserve the unique rural character of the park while providing a balance between agricultural heritage, wildlife conservation, and recreational uses".

The rationale behind prohibiting dogs from the Terra Nova Rural Park was to protect the sensitive wildlife areas and the proposed gardening/ farming areas. The park has developed over the last 5 years and is now home to a number of farming, gardening and wildlife initiatives that address issues such food security and sustainability, as well as provide opportunities for community engagement. These initiatives and land uses include:

- 1. Trail use by the public
- 2. Wildlife habitats
- 3. Community garden plots (public use)
- 4. Terra Nova Schoolyard Society garden plots (school program use)
- 5. Fruit Tree Sharing Farm areas (food grown for the food bank)
- 6. Kwantlen University Farm School programming (in collaboration with the Fruit Tree Sharing Farm)

The park is unique to Richmond and the Lower Mainland in its design which incorporates the historical farm use of the area with native species habitats.

The majority of park users are respectful of the ban on dogs, however, there are some who continue to bring dogs into the rural area. Concerned citizens have contacted the City about dogs in the park, however at this time staff are limited in the course of action they can take.

If the attached bylaws are adopted Community Bylaws staff can respond to concerns about dogs in the park by issuing a ticket if necessary. The goal is not to generate money from tickets, but rather to provide a tool for animal control officers to use if needed, while protecting agricultural and wildlife areas.

Park users in the Terra Nova area will still have the option to enjoy the Terra Nova Natural Park and the dyke trails provided their dogs are on a leash (see attachment 3 for map). This area does not have any agricultural projects and was designed with a waterway that acts as a moat. This prevents access to the old-field habitats which reduces the potential negative interactions between nesting birds and dogs.

Financial Impact

No financial impact. Based on the historical number of complaints regarding Terra Nova Rural Park, enforcement will be covered using existing divisional resources.

Conclusion

Terra Nova Rural Park is a unique and award winning park housing a variety of community programs. In order to preserve the integrity of the farming/gardening and sensitive natural areas, it is important for the ban on dogs to be continued and for staff to have a way to enforce the ban when necessary.

Public Parks and School Grounds Regulation Bylaw No. 7310 Amendment Bylaw No. 8612

The Council of the City of Richmond enacts as follows:

- 1. Public Parks and School Grounds Regulation Bylaw No. 7310, is amended by adding the following after section 1.6.2:
 - 1.6.3 A person must not bring or permit any dog under his or her care, control or custody within the boundaries of Terra Nova Rural Park.
- This Bylaw is cited as "Public Parks and School Grounds Regulation Bylaw No. 7310, Amendment Bylaw No. 8612".
