# **Noteworthy Files:**

#### Reminder to Animal Lovers

The Richmond RCMP would like to remind the public to take extra care and control of your animals when you are out and about with them. On January 31<sup>st</sup>, the Richmond RCMP was called to a dog bite complaint to the area of Alberta Road and Katsura Street. A mother was walking slightly in front of her 7 year old son when she heard him scream. The mother looked back to find a dog biting her son and attempting to drag the boy away. The dog had been seated inside a vehicle and managed to jump through an open window. The owner, also in the vehicle, restrained the dog and secured him back in the vehicle. The boy sustained a bite wound with skin breakage and minimal bleeding. He was taken to the hospital for treatment. Animal Protection and Control were advised of the situation.

### Bait Car Activation - Two Men Arrested

On February 8<sup>th</sup>, the Richmond RCMP responded to a Bait Car Activation just before 1:30 am. The suspects drove into Vancouver and dumped the vehicle in a residential driveway. Both the driver and passenger fled on foot but were apprehended by Vancouver City Police and the Lower Mainland Police Dog Services. One of the suspects sustained a bite from a Police Service Dog and was taken to the hospital. Both suspects, age 42 and 47, have extensive criminal records dating back to the early 1980's. The men have been released on a Promise to Appear with a court appearance in May. This is a great example of how even the most seasoned criminals are not immune to getting caught by the Bait Car Activation.

### Road Safety Reminder

Drivers must slow down and yield to pedestrians and other road users who have the right of way. People's lives are on the line and all road users need to be vigilant. The Richmond RCMP is investigating a number of pedestrian and vehicle collisions. Since the beginning of February 2010, there have been a total of 10 incidents where pedestrians have been struck by a vehicle, two of which have been fatal. These collisions were unnecessary and are traumatic for the families who have lost loved ones. The majority of pedestrians are being struck in intersections

where they have the right of way. The RCMP has a message for drivers: slow down, be vigilant and obey all road rules. All road users need to take ownership of their own safety and those around them.

## Richmond RCMP Locate Missing Male with Alzheimer's

On February 22<sup>nd</sup>, the Richmond RCMP were called to assist a family in locating an 87 year old man with Alzheimer's disease. In the early morning, the elderly man was noticed missing by his wife and she called the police. An extensive search was conducted immediately and included the Lower Mainland Police Dog Services. The search continued for an hour before the RCMP located the 87 year old man in a bush along the Shell Road tracks. He was curled up in a ball dressed in only a t-shirt and pyjama bottoms with no shoes or jacket. He was suffering from hypothermia and was transported to the hospital by the RCMP. The male was kept in hospital for assessment and released later in the day. Had he not been found, he may not have survived the affects of the cold.

### **Interactive Crime Maps**

The Richmond RCMP would like to advise the public of the interactive crime maps now available for the public. The RCMP Block Watch/Crime Prevention Unit, in partnership with the City of Richmond's IT Department, has launched an interactive criminal activity map that can be accessed on the City's website. Visit <a href="www.richmond.ca/crime">www.richmond.ca/crime</a> where you can view Richmond neighbourhood maps for current crime summaries of residential break and enters, auto thefts, and theft from motor vehicles. Visitors to the site will be able to select one of the five coloured areas to display a larger map of the zone/area requested then select the individual neighbourhoods. This will allow viewing of the criminal activity in that area since January 1, 2007. There will also be additional information sections in regards to securing vehicles (under Theft from Motor Vehicle) and homes (Residential Break and Enter). The website is also a resource for crime prevention initiatives; home invasions; tips for landlords, including how to prevent marijuana grow operations; and current media releases.

- The decrease in Property Crime this month is due almost entirely to a 40% reduction in Theft from Vehicle
  offences. This may be due to the arrest or displacement of one or more prolific offenders, or perhaps the
  volume of people and police officers during the Olympics had an impact on certain Property Crimes; both
  Residential and Business B&Es decreased during February.
