**Staff Report****Origin**

Pursuant to Section 168 (1) of the Community Charter, the total remuneration, benefits and expenses incurred by each member of Council must be reported annually.

**Analysis**

Total salaries paid to Council members for the year 2009 was \$510,267 and the cost of benefits was \$41,375. Total expenses incurred were \$28,765. The schedule below provides a summary for each Council member.
