Staff Report

Origin

The City of Richmond in partnership with all regulating jurisdictions continue to enforce City bylaws with an emphasis on businesses operating within the guidelines of all applicable bylaws, statues and regulations and the permissive functions within the business complex. These ongoing efforts promote community, customer and employee safety and prevent any business from gaining an operational advantage over another business in the same licenced category.

This report deals with By-Law infractions noted as a result of routine inspections at Sun & Body Glo Services Inc. operating from premises located at 201-3871 No. 3 Road, Richmond, B.C.

Analysis

On January 31, 2009, at approximately 10:26 p.m., members of the Richmond RCMP Police, including Constable Alex Upshall, conducted an inspection of Sun & Body Glo Services Inc., licensed as an Adult Oriented Use (AO) category that must adhere to the Body Rub Studio Regulations, Part Seven of the Business Regulation Bylaw No. 7538.

During the Inspection of January 31, 2009, Constable Alex Upshall found Sun & Body Glo Services Inc. to be operating in violation of the Business Regulation Bylaw No. 7538, section 7.3.1 (c) which states:

7.3 Operator Prohibitions

7.3.1 An operator of a body-painting/body-rub studio must not:

(c) permit any person engaged in providing a **body-rub** or other service to be in such premises *unless such person is wearing* clean, washable, non-transparent outer garments, covering his or her body between the neck and the top of the knee, the sleeves of which must reach below the elbows;

Staff consider the activities occurring during the by-law violation warrant Council's consideration under Section 15.1.e of the Community Charter which provides for suspension or cancellation of a licence for failure to comply with a term or condition of a licence. In addition, Section 60.2 of the Charter also provides Council with the authority to suspend or cancel a licence for reasonable cause.

On Friday, June 5, 2009, a Show Cause Hearing for licence suspension was held in front of the Chief Licence Inspector. Present were Ms. Julia Alexandrov Gulnara, the principal owner of Sun & Body Glo Services Inc., Constable Alex Upshall, member of the Richmond Detachment, RCMP Police and Mr. Victor Duarte, Business Licence Inspector for the City of Richmond.

Mr Duarte provided a comprehensive overview of the background and facts as outlined in the attached information. (Appendix 1)

Constable Alex Upshall provided information supporting the overview of Mr. Duarte to the Chief Licence Inspector as to the findings of his inspection conducted on January 31, 2009.

Ms. Gulnara was provided an opportunity to speak and stated she was not at the business when RCMP attended and has recently taken over as managing director of the business. Ms. Gulnara advised that her staff denied anything had occurred and this was the first time she has heard the facts as provided to her at the hearing. Ms. Gulnara then stated her business was not of such nature and promised it would not occur again. She has advised her staff of the by-law regulations and expects them to follow them, and if they do not, they will not be permitted to work for her any longer.

Having completed the review and taking into consideration information received from the Managing Director, the RCMP, the City's Business Licence Inspector, and this being the first documented offence, it is the opinion of the Chief Licence Inspector that Sun & Body Glo Services Inc. should have their Business Licence suspended for a period of 30 days.

Conclusion

Sun & Body Glo Services Inc. has contravened the City's Business Regulation Bylaw and as such, their non-compliance warrants a suspension of 30 days that should be enforced from October 2, 2009 to October 31, 2009 both dates inclusive.

History:

Sun & Body Glo Services Inc, doing business as, and here in after referred to as Temptations Studio, operates at Unit # 201-3871 No. 3 Road, in the City of Richmond. Temptations Studio has operated at this location since 1987. Temptations Studio is licensed as a Body-Rub Studio under the City of Richmond Adult Orientated Uses category and as such, is subject to ongoing routine inspections, conducted by Richmond RCMP Police and City of Richmond Inspectors.

On April 3, 2002, Caroline TOOMANI acquired 40% of **Temptations Studio**, and continued operating until August 11, 2008, where TOOMANI applied as sole principal owner.

On July 11, 2008, City of Richmond's Licence Inspector Victor DUARTE, here in after referred to as DUARTE, received an enquiry in regards to **Temptations Studio**, from Cst. D. EDGE, of the Richmond RCMP, Criminal Intelligence Section. Cst. D. EDGE had concerns with the sexual and explicit content of the website being operated by **Temptations Studio**. DUARTE reviewed the website and it was apparent that the nature or allusion of the content was unequivocally sexual, and a service which would not be covered by any licence category.

The website referred to the body-rub employees of **Temptations Studio**, as Stars and welcomed the viewers to "Meet the Starrz" by viewing the provocative photos of scantily dressed females in lingerie or in some cases, nothing at all. When the profiles of each Starr was reviewed, the viewer was provided with acronyms of the special services provided by each Starr.

Cst D. EDGE acquired the assistance of a colleague of the Vancouver Police Department, Vice Squad, Detective/Cst. M. HOLM, in deciphering these acronyms. Cst. D. EDGE provided DUARTE with a description for these acronyms obtained from Det./Cst. M.HOLM. These acronyms clearly depict services which are sexual in nature and services not covered under any licence category.

On August 07, 2008, DUARTE sent a warning letter to TOOMANI in regards to the content of her website. The letter expressed the content, activities or related activities at the business premises to be violations of the terms of their business licence and activities not endorsed by the City of Richmond. TOOMANI was informed if these activities were found to be occurring, enforcement steps could be taken which included the suspension or cancellation of her business licence. The website was changed soon after. (Copy of Letter) **Attachment 1**

DUARTE, received a call from TOOMANI in the first week of April of 2009. TOOMANI was informed by DUARTE as a result of activity that occurred at her business, there may be a Show Cause Hearing scheduled.

City of Richmond received notification on April 20, 2009 that there was a change of ownership of **Temptations Studio**. Julia Alexandrov GULNARA, a current employee of **Temptations Studio** submitted an application for licensing as the new owner.

DUARTE spoke with GULNARA on April 22, 2009 in regards to her knowledge of an upcoming Show Cause Hearing and left a letter with GULNARA at this time informing her of the time and date of the scheduled hearing. GULNARA was aware of a pending hearing in regards to activities noted by Richmond RCMP Members that attended on January 31, 2009. (Copy of Letter) Attachment 2

Current Information:

On January 31, 2009 at approximately 10:26 p.m., Csts UPSHALL, LANGLEY and WROBEL attended **Temptations Studio** for a routine inspection. Cst UPSHALL noted one customer in the premise found inside a room with female employed/engaged by **Temptations Studio**.

During this inspection, an employee was noted to be naked inside the room with the customer. This is a violation of the Business Regulation Bylaw No 7538, section 7.3.1(c), which states; An operator of a body-painting/body-rub studio must not permit any person engaged in providing a body-rub or other service to be in such premises unless such person is wearing clean, washable, non-transparent outer garments, covering his or her body between the neck and the top of the knee, the sleeves of which must reach below the elbows. A Municipal Ticket Information (MTI) was issued by Cst UPSHALL for this violation. (Copy of MTI) – **Attachment 3**

On February 22, 2009, Cst CHAPLIN conducted an inspection of **Temptations Studio** with other Richmond RCMP officers. Cst. CHAPLIN observed a white communication board in the employees room, with the phrase "the police raided us last night" and "ensure all employees are in the break room before opening the door to the police" It is the belief of the RCMP and DUARTE that this phrase is to prevent further violations from being observed by RCMP Members or City of Richmond Inspectors and if this is the case, it violates the obligation of providing reasonable inspection access. Corporate Search of **Sun & Body Glo Services Inc.** on May 29, 2009 shows GULNARA as a Director and still lists TOOMANI as Officer, title as President. (Copy of Incorporation Certificate) – **Attachment 5**

The City of Richmond continues to enforce bylaws with emphasis on businesses operating within the guidelines of all applicable bylaws, statutes and regulations within the business premises. These ongoing efforts are in order to promote customer and community safety.

A licensee, operator, or any other person who violates or who causes or allows any provisions of the Business Licence Bylaw, Business Regulation Bylaw, or fails to comply with the provisions of any other bylaw or statute, is deemed to have committed an infraction of the Business Licence Bylaw No 7360 or the Business Regulation Bylaw No 7538 and could result in the suspension or cancellation of the licence. In careful consideration of the severity and noted infraction of the Business Regulation Bylaw and the Business Licence Bylaw, it is the undersigned's belief that a licence suspension or cancellation is warranted.





Constable CHAPLIN will say that since March 19th 2007 Constable CHAPLIN has been a regular member of the Royal Canadian Mounted Police. Since March 19th 2007 Constable CHAPLIN has been assigned to the Richmond Detachment of the Royal Canadian Mounted Police.

On February 22nd 2009 Constable CHAPLIN was working in plainclothes and riding in an unmarked police vehicle.

On February 22nd 2008 Corporal Peters, Constable SHIN and Constable CHAPLIN attended Temptations Massage located at 3871 No 3 Road. Constable CHAPLIN rang the buzzer three or four times, and knocked on the door. Richmond R.C.M.P. members had to wait approximately thirty seconds before being buzzed into the business.

As members entered the business Constable CHAPLIN identified himself by showing a R.C.M.P. badge worn around the neck and informing "Police". Constable CHAPLIN was informed there were no customers inside the business currently, and all the employees were in the front room.

Constable CHAPLIN entered the front room , and observed four females, a television, and several close circuit video cameras.

Constable CHAPLIN while talking with the females observed a white communication board; written on the board were the phrases "the police raided us last night" and "ensure all employees are in the break room before opening the door to the police".

The attending members did not observe any bylaw infractions at the time of attendance.


