Staff Report

Origin

Council Resolution Nos. R07/19-7, R07/19-8, R07/19-9 on November 13, 2007 resolved that a "three year Activity Plan be presented to Council for approval by the end of the first quarter of 2008 and thereafter in accordance with the new Program policies and procedures and updated Sister City Terms of Reference" Also, that

"the Sister City Committee report to Council on an annual basis on the measurable outcomes of the specific activities undertaken by the Sister City Committee with our various Sister/Friendship cities." This report includes the 2009 Sister City Committee Annual Report.

At the April 6, 2009 meeting of the General Purposes Committee, a report was presented by staff regarding the Richmond Sister City Committee 2009-2010 Activity Plan. The 2009 Activity Plan was approved and the 2010 Activity Plan was referred back to staff for further analysis. This report provides updated information for the Committee's consideration.

Analysis

The primary purpose of the City of Richmond's Sister City Program is to foster mutual understanding and meaningful connections with other cities and cultures in the interests of our citizens for their common benefit. Projects and exchanges should promote cultural awareness, joint learning opportunities, economic development and trade.

The Sister City Committee develops a broad base of activities for Sister/Friendship City relationships in which many people and organizations in Richmond and the Sister/Friendship community participate through planned and on-going contact.

With these goals in mind, and in order that the Sister City Committee have a clear understanding of their role and objectives, the 2010 plan is attached. This plan identifies cultural, educational and economic priorities for 2010 and has a proposed program of activities and events.

Staff does not support the Sister City Committee's 2010 Plan in its entirety. Staff support all aspects of the 2010 Plan except the component involving a program in Shanghai. Shanghai is not an official Sister or Friendship City and staff believe any possible City led mission to the Shanghai Expo should be justified by economic development benefits.

The theme of the 2010 Shanghai Expo is "Better City, Better Life" and Canada is participating through a Canada Pavilion that is available for Canadian government and non-profit partners of all three levels to use during the Expo from May 1st to October 31st 2010. Staff were asked to assess the opportunity for the City to participate in the Expo and initiate an economic development program for the City of Richmond.

In determining potential economic development benefits to the City of Richmond of participating in 2010 Shanghai Expo, staff undertook the following steps:

- 1. Sought feedback from the Economic Advisory Committee on the merits and potential of Richmond participation in the 2010 Shanghai Expo.
- 2. Surveyed what, if anything, major business stakeholders in Richmond are doing to participate in 2010 Shanghai Expo.
- 3. Sought feedback and opinions from the Richmond Chamber of Commerce and Tourism Richmond.
- 4. Generated data and assessed what other municipalities, senior government, industry associations and other non-profit entities are planning for Shanghai Expo 2010.

Staff viewed this opportunity from the perspective that an economic benefit for Richmond is a key requirement for deriving value out of Shanghai Expo 2010. Staff concluded that there is not sufficient economic benefit to Richmond participation based on:

- The uptake from the EAC was rather neutral, with major businesses represented on the EAC not planning significant activation in Shanghai.
- The Chamber is pre-planning a mission to Xiamen this fall, which will target 10-12 local companies with strong business interests in the Xiamen market. This is in response to an invitation from the City of Xiamen and is planned to be coordinated in the third week of September
- Tourism Richmond has indicated that if there are benefits from the Shanghai Expo to marketing Richmond to the tourism industry in Shanghai, they may be interested in going. It is noteworthy that Tourism Richmond are already in China developing relationships with the tour and travel industry and markets.
- Both federal and provincial participation in Shanghai Expo is minimal and highly political in nature (ministerial rather than business visits), with no business-to-business component solidified to date.
- Other local governments (including Metro Vancouver Commerce municipalities) are not interested in participating, except for Vancouver who are developing an exclusively Vancouver-branded event on September 10 at their pavilion, with little industry participation expected.
- No senior government or other funding sources exist to leverage travel costs and any Richmond participation, in partnership or not, needs to be self funded
- Funding requirements could be anywhere between \$60,000 and \$100,000, including up to \$7,000 per head in travel costs and up to \$30,000 for a reception, with the source of potential funding currently unclear.

With these factors considered, staff does not see the benefit of creating a Richmond focused economic development program for the Shanghai Expo.

Another report to Committee has a staff recommendation to continue a Friendship City relationship with the City of Qingdao. Should this relationship not continue, the 2010 Plan would change accordingly.

This Plan is very ambitious and continues to have an impact on staff resources. Two staff from Corporate Services are currently assigned to liaise with this committee. They are working at capacity in their efforts to provide support. Should the Sister City Committee want to establish additional goals, it would be difficult to achieve at current levels of staff support.

Financial Impact

The total Program budget for 2008-2010 is \$150,000.00 The committee has \$80,000.00 in the current year's budget. There is no net impact to the 2010 budget as a result of this recommendation.

Conclusion

The Sister City Program is a valued and long-standing City program. It is supported by the Sister City Committee, a dedicated group of community volunteers who are committed to achieving their goals. Approval of the 2010 Plan will set clear direction for the Sister City Committee to maintain robust and meaningful Sister and Friendship City relationships. The current plan that includes a trip to the Shanghai Expo can not be fully endorsed by staff. If the Shanghai component is excluded, staff support the plan.

CITY OF RICHMOND SISTER CITY COMMITTEE 2010 ACTIVITY PLAN AND BUDGET

PRIORITIES

- 1) SCC Policy and Guidelines state that the frequency for an official delegation exchange with a Sister City should take place each three years. The last Richmond official delegation visited our Sister City, Wakayama, Japan in the spring of 2005 in conjunction with a trade delegation to Expo 2005 in Nagoya Japan. In 2005 a program of activity was developed for the visit in partnership with the federal department of Canadian Heritage, local business and secondary and post secondary education officials. In 2008 an official 35 member delegation led by Mayor Ohashi, City Councillors, Dr. Iwahashi and members of Wakayama Sister City Committee visited Richmond to celebrate 35 years of twinning. Recognizing that it is our turn to visit Wakayama, officials have requested that we conduct our official visit in 2010 rather than 2011 as Wakayama will be in Bakersfield, California in 2011 celebrating 50 years of their twinning relationship. The Committee is also planning to visit China in order to promote the interests of Richmond as well as further enhance our friendship city relationships there.
 - a. The SCC will organize and lead an official City of Richmond delegation to the Sister City of Wakayama, Japan in the second half of 2010. As per policy the visit will be over four days and three nights.
 - b. Objectives: The SCC will work with the Wakayama International Affairs office to develop a program focused on the Wakayama region's agriculture, tourism, parks and green technology. It is expected that the program will include their highly successful Kuroshio Market, where seafood and local products are exhibited and sold; the Yuasa district which is the birthplace of Japanese soy sauce and its warehouse and museum adjoining Kadocho Soy Sauce; the plum groves of Minabe, famous for pickling and international export and Arida mandarin oranges.
 - c. Program budget for trip attached.

Part B of visit to Asia: Visit to Friendship Cities of Xiamen, Qingdao, and Expo 2010 in Shanghai. The City of Xiamen is about a two hour flight from Osaka, with 61 flights a week connecting by eight different airlines while the City of Qingdao is just over an hour flight from Osaka with 88 flights a week and 10 airlines. Both cities show Shanghai as the most popular connection for one-stop flights. It makes both economical and logistical sense to try and time the visit to our Sister City in Asia with our two Friendship Cities.

a. The SCC has been working with the International Committee of the Chamber of Commerce to bring together like business interests in Xiamen and Richmond. Last year the Chamber hosted two luncheon presentations for visiting business delegations from Xiamen. In 2008 the President of the Chamber travelled with the official delegation and met with the Xiamen Chamber of Commerce to explore joint business opportunities. The Chamber is now prepared to travel with a business delegation to conclude two or three agreements. The SCC and the International Committee believe there is much value in signing these first

agreements in Xiamen as well as in the Canadian Pavilion in Shanghai during a Richmond Day (similar to 2005). It is planned that the Chamber's trip will be arranged by the BC Economic Development Ministry, but will overlap for certain business events with the City of Richmond to achieve maximum success. Another major developer has expressed an interesting in partnering in a Richmond Day, as has Xiamen business to participate in such an event. In addition, the SCC has been approached by a representative of another community who followed our lead and signed two friendship agreements in China late last year and asked if we would be interested in hosting a day long joint business fair in Shanghai. They have strong connections in the private education sector.

- b. Over the last 10 years the SCC has developed strong relations with senior representatives in Asia's travel industry. The SCC would use these contacts to significantly reduce the costs of a combined trip. In addition the SCC will work to assist tourism in the promotion of Richmond and to support Approved Destination Status (ADS).
- 2) The primary focus for the SCC base program activities in its relations with our Sister Cities and Friendship Cities is to assist in building bridges and connections in order to engage the Richmond Community and its Sister/Friendship cities abroad in projects and exchanges that promote cultural awareness, joint learning opportunities, trade and economic development.
 - a. Thirty-five students and teaching staff from Wakayama will visit Richmond schools for a five-day visit over the May long weekend. During the past year the SCC worked with the Richmond Board of Education to reinvigorate the exchange program between students of Wakayama and Richmond. The SCC is committed to supporting the new district exchange by providing bus transportation and hosting an event each day of the visit. See budget attached.
 - b. In order to support economic development opportunities the committee will work to complement and enhance the activities of the Economic Development Office of the City of Richmond, the Economic Advisory Committee, and partner organizations such as the Chamber of Commerce, Tourism Richmond and the provincial and federal government economic development offices using the connections established with our Friendship and Sister Cities.
 - c. The SC Committee will work to support opportunities for visits to Richmond after the implementation of the ADS for Chinese visitors.
 - d. In order to broaden the community involvement in Sister City and Friendship City relations the SCC will work to further develop the close working ties with local friendship city associations such as the Xiamen Friendship Society of Canada, Richmond-Qingdao Friendship Association, Qingdao Fellowship Association, Fujianese Friendship Association and Wakayama Kenjinkai.
 - e. In order to broaden the impact and connections of SCC activity it is important to involve and utilize partner organizations (Chamber of Commerce, Tourism Richmond and Friendship Societies) to assist and coordinate visiting delegations from their corresponding cities. The SCC aims to develop closer liaisons and recruit people from these organizations to serve as advisory members.

- f. The SCC will encourage Social networking with our Cities through Facebook, Twitter, etc. Work with Tourism Richmond as a host for such activities. This has not yet been discussed with the Information Technology Division.
- g. The SCC will expand relations with post secondary institutions in Richmond, linking with Kwantlen University, Trinity University and BCIT. The Committee will identify and contact point people in each of these institutions.
- h. The SCC will continue to reinvigorate School Exchange programs with Wakayama, and our other SCC cities.
- i. The SCC will continue to strengthen relations with Friendship Associations, Richmond Chamber of Commerce, Tourism Richmond and Foreign Affairs Offices establish clear communication and organizing protocols headed by SCC for visiting delegations among the organizations mentioned.
- 3) As a Host City of the 2010 Winter Olympics the SCC will develop a hosting program for our two Sister Cities.
 - a. The SCC will provide logistical assistance in order to secure hotel nights and tickets at their own cost or offer a home stay program.
 - b. The SCC will develop a program of activities that will showcase the Richmond Olympic Oval, tourism opportunities in Richmond, connect with representatives of the Richmond Board of Education, and profile local business.
- 4) The revised policy, mandate, terms of reference, and budget support for the activities of the SCC has had immeasurable positive and unexpected outcomes, as demonstrated by the success of the Xiamen Philharmonic Orchestra performance in October 2009. The event was funded through ticket sales, sponsorships, and countless volunteer hours from both Richmond and Xiamen business. The SCC has had offers to repeat business sponsorship both here and in China. An immense pride for our community of Richmond was brought together through a unique cultural event. The accolades for the City of Richmond and its special vision through the activities of the SCC found their way into many media articles and Internet blogs. It is necessary to:
 - a. present to Council the future vision, program and budget request for activities and visits and delegations for the next three years, as the three-year base program funding ends in 2010;
 - b. improve Sister Cities and Friendship Committee presence on the City website and in various languages (French version for Pierrefonds, Japanese version for Wakayama, Chinese for Xiamen and Qingdao). Create reciprocal links to sister and friendship cities (See Wakayama's website);
 - c. continue to develop archiving program and SCC promotional material;
 - d. establish SCC fund raising initiatives to develop the means to maintain, beyond the three-year sister city government funding program, the activities of four sister/friendship cities; and
 - e. review our status with Xiamen and Qingdao as friendship cities and determine if there is substantive basis to graduate either or both cities into full-fledged sister city status. Determine the interest of each city in becoming a Sister City. As well, continue to maintain casual relations with Yantai/Yangzhou to assess if there is value in developing further relations with SCC.

- Xiamen delegation visit in May to promote CIFIT.
- Qingdao Judo Club is expected to visit Richmond in fall 2010. Link with Steveston Judo Club.
- Propose to host the internationally renowned Wakayama Children's Choir May 2011. Link with the Richmond Community Orchestra and Choir.
- Plan for an athletic exchange with Pierrefonds in 2011.
- Plan for 45th Anniversary with Pierrefonds in 2012.
- Plan for visit to celebrate 40th Anniversary with Wakayama in 2013.

3) Base Program Activities (non-visit)

- July 1st Salmon Festival Parade. Sister City Committee and Sister Cities as well as Friendship Cities to be involved.
- Annual state of the city letter from Mayor and City's annual report and any new significant city plans from CAO/Senior staff to be sent out.

YEAR IN REVIEW

2009



The Sister City Committee of Richmond has earned the reputation as one of the top ten most active Sister City Committees in Canada. 2009 was a remarkable year that saw the SCC undertake its most significant cultural event of the decade - hosting the Xiamen Philharmonic Orchestra for four days and two concert performances at the River Rock Show Theatre.

The Committee believes that the benefits of hosting the Xiamen Philharmonic Orchestra were very significant and multi-level, and fulfilled the Committee's mandate not only for cultural events but also for joint learning opportunities and economic benefits. This activity of the SCC reached a very broad audience and benefited the community with an important multi-cultural event that generated much goodwill and pride in our City. So many volunteers, city staff and, significantly, business both in Richmond and in Xiamen contributed to its success. As this was not an event funded from the Committee's 2009 budget, the cost of hosting 96 people for the entire visit, from Friday morning until their departure on Monday, was based on the Committee's ability to generate sponsorship, sponsorship in kind, and ticket sales. The success of the XPO visit, both culturally and financially, was particularly significant as the event occurred as a worldwide recession set in and companies cut their sponsorship budget significantly.

Thanks and accolades go to many but in particular, recognition must go to Walter Soo, SCC member, and Juliana Yung, Friend of SCC who Co-Chaired the two performances of the Xiamen Philharmonic Orchestra.

February 6, 2009

SCC Members Richard Toda, Sylvia Gwozd, Priscilla Bollo, Francis Turmeau, and Joe Greenholtz attended a presentation at the UBC Centre for Japanese Research entitled "Japan-US Sister City Exchanges: Assessing the value of the Bellingham Tatayama Relationship" by Patrick H. Buckley, of Western Washington University. The primary exchange activity between Tatayama, Japan and the City of Bellingham is the exchange of City staff. Staff would stay for a one or two week period shadowing their counterpart. This research project attempted to measure the economic benefit of the exchange. Ouantifiable measures are difficult but could measure the number of students, hotel room nights, air traffic, city participation etc. This report identified that the most important benefit to a Sister City relationship is quality of life and community sustainability. Researchers could not find any one who had been able to measure such data. The researcher developed a research model called the Delphi Model based on exchanges between 1992 and 2006. Participants (anonymous) were interviewed through a guided discussion, which began with an evaluation of each city's Quality of Life in twelve areas, then were asked what each city could learn from the other. Did the exchanges show cultural borrowing and sharing of new perspectives? The preliminary results of the study suggest there is value in such exchanges as they stimulate participants to think about things, each city sees things in the other that it does not in its own, bringing forth suggestions on how to improve the quality of life for its citizens. (Refer to website http://www.bsca.org/ for Bellingham Sister Cities.) Bellingham has sister cities in Japan, Russian, South Korea, Australia, Chile, and Finland.

March 21, 2009

Vice Chair Relations with Friendship Cities in China, and Co Chair XPO event Bennie Yung passed away on March 21, 2009. In 2006 Bennie was chosen by the Vancouver Sun as one of the 100 Influential Chinese Canadians in B.C.

March 27, 2009

Sylvia Gwozd, Max Liu, and James Hseih attended a luncheon hosted for Hon. Changfu Han, Governor of Jilin Province, China at the Pan Pacific Hotel. Minister Stockwell Day greeted him, and Richmond GenCap Equity Inc. Susan Schwetje, Sr. Manager Marketing and Support Canada, and Tri Star Seafoods were major sponsors of the event.

April 2009

Sponsorship drive began for Xiamen Philharmonic Orchestra event, and SCC members met with Alice Wong, MP, and various potential corporate sponsors, and community centre representatives.

Jim Kojima, Vice Chair, Relations with Wakayama, Japan travelled on a private visit to Japan. The City of Wakayama hosted a special dinner to honour Jim's contributions to the promotion of lasting relationships in the twinning of the City of Richmond and the City of Wakayama.

May 2009

Sponsorship drive was successful, and met its \$50,000 goal. Staff presented a report to Council who gave official approval to proceed with XPO event. Walter Soo, SCC member and VP, of the Great Canadian Gaming Corporation and Juliana Yung, Friend of SCC and VP Business, G& F Financial Group, volunteered to Co-Chair the XPO visit and performance.

Richmond Sister City Committee Invitation to Xiamen Philharmonic Orchestra Council adopted the following recommendation in connection with the above:

- (1) That authorization be given to the Richmond Sister City Committee, on behalf of the City of Richmond, to invite the Xiamen Philharmonic Orchestra to perform in Richmond between October 3-6, 2009; and
- (2) That the General Manager, Corporate Services, or his designate, be authorized to execute any necessary agreements or documentation in relation to the Xiamen Philharmonic Orchestra performance

May 26, 2009

Former Chair of SCC Gord Ellis passed away. Gord's contributions to the Richmond community consisted of long-time involvement in the Kinsmen Club, Richmond Sister City Committee, Tourism Richmond, and he was the first recipient of the 2000 Volunteers Are Stars Award.

May 2009

As part of the program to reinvigorate the exchanges between Wakayama Schools and Richmond Schools four London Steveston students plus two teachers travelled to

Wakayama. Wakayama City went beyond the call of duty to home-stay students and provided a culturally rich experience. Students went to Mio and met with a former resident of Steveston who as an adult moved back to Japan.

This trip was one of the main priorities in terms of budget and activity of our committee this year and part of the rebuilding program for the school exchanges between Wakayama and Richmond. The extraordinary work of the Wakayama International Division along with the Sister City Committee must be recognized in view of the outbreak of H1N1 flu and the intense Japanese media against anyone from the Americas. Eighty people from Wakayama including Mayor Ohashi, some Councillors, the Wakayama Affiliation Committee, and Board of Education staff welcomed the Richmond visitors.

May 15 - May 24 visit of Steveston-London to Wakayama

The Sister City Chairman, Dr. Iwahashi and the Foreign Affairs Department of the Wakayama City, Mr. Hayashi, made arrangements for everyone to be billeted and trips planned in Wakayama, Hiroshima, Kyoto, Nara, Mio, Osaka, to experience more of the culture, traditions in other parts of Japan that will give the students and teachers a great experience of Japan. Teachers from Steveston-London: Dan Stewart homestays at Mr. Hayashi's (retired B of Ed and seconded to work on SCC in International Div.) house and Connie Easton will be staying at Ms. Kitagawa's (Vice Chair SCC) house.

Steveston-London Students: Mr. Andrew Yan, Mr. Kish Lee, Ms. Devon Fremantle, and Ms. Joanne Ho.

June 2009

CBC radio French channel asked Vice Chair Francis Turmeau to be interviewed about Pierrefonds and the Sister City Committee goals in general. They were also interested in knowing about our other Sister Cities.

June 1, 2009

Max Liu, Vice Chair relations with Xiamen visited that city and met with FAO Xiamen. Attending the meeting was the Deputy Director General Mr. Li Xiao Ping, who had recently received an MBA from UBC, Mr. Leon Yu, and Mr. Casper Lian who was responsible for translation services for the XPO. Also in attendance at this meeting were Mr. Lin He Ping and Mr. Chen Kai Jun from the Canada-Xiamen friendship Association. Discussion centered on details of XPO visit. The new itinerary without final confirmation was that they would arrive in Richmond on October 3 from Tokyo by JAL and leave for San Francisco US on October 6. The following day Max Liu met with XPO and the conductor of XPO, Madam Zheng Xiaoying.

June 4, 2009

Max Liu, Vice Chair met with FAO Qingdao and traveled to Zhongshan Park to determine the best place to plant the trees for a tree planting ceremony.

June 16, 2009

In honour of our first anniversary of relations with the City of Qingdao, Mayor Brodie sent an official letter to Mayor Xia Geng. The SCC marked the occasion with an official dedication of maple trees in Qingdao.

Vice Chair, Max Liu represented and spoke on behalf of the SCC at the maple trees donation ceremony. The following letter was read at the dedication ceremony on June 17, 2009:

"The Richmond Sister City Committee is proud to work with the Foreign Affairs Office in the City of Qingdao to further the official friendship established between our two cities just over one year ago.

We are pleased that along with the Qingdao Friendship Association, we were able to join with the Forestry Innovation Investment Ltd. (FII) in working with Qingdao authorities to develop a landscaping demonstration project and that in this endeavour we were able to plant 9 maple trees in Zhongshan Park that will honour the strong bond that we are establishing between our two cities and two countries.

Since 1965, the maple leaf has been the centrepiece of the National Flag of Canada and the maple tree bears the leaves that have become the most prominent Canadian symbol, nationally and internationally. Maple leaf pins and badges are proudly worn by Canadians abroad, and are recognized around the world. July 2009

One hundred and fifty books arrived in the Richmond Public Library, a special donation by Mayor Liu Cigui, Mayor of Xiamen, as a result of his visit in the fall of 2008, and his tour of Richmond's award winning library. Mayor Liu was inspired to undertake this personal project as Xiamen's sister city in Australia had organized a similar book donation to the Xiamen library. A special recognition ceremony with the Richmond Public Library was planned for November.

July 27, 2009

At the 2 p.m. show special guests were the Richmond Youth Honour Choir, singing "The Song of Richmond", and at 7:30 p.m. special guests were the Richmond Orchestra and Chorus featuring the Chorus performing "A song of Hakka". The Master of Ceremonies was David Fromager, Music Director and Conductor, Richmond Youth Concert Band and John van Deursen, Instructor of Conducting,

University of British Columbia, and Viktorie van Deursen,

translating into Mandarin.

experience. We were gratified that the audience was noisily appreciative and in the end our membership was overwhelmed by the warmth of inclusion in this program that truly celebrated multi-cultural excellence.
