 THE 12115 / 12113 + 12111 ADDRESSES ARE NOT
 SHOWN IN THE CORRECT WAY. THEY ALL FRONT
 ON TO 1ST AVENUE, WITH PARKING LOTS IN
 THE BACK.

I ALSO BELIEVE YOUR PETITION DECISION IS
 NOT LEGAL. WHEN THE STORE OWNERS +
 NEIGHBORS OF THE LITTLE STEVESTON PARK
 FOUND OUT ABOUT THE PLANS TO MOVE THE
 BUILDING BEHIND THE POST OFFICE, THUS
 RUINING THE ONLY QUIET, SHADY PARK IN
 OUR AREA, WE SIGNED A PETITION.
