## Staff Report

### Origin

The Waterworks and Water Rates Bylaw is amended each year to reflect the anticipated rates at that time and to determine the waterworks requirements. Staff is proposing a minor amendment to this bylaw to reflect the current requirements of the strata titled properties.

### Analysis

The current bylaw requires that metered strata properties apply to the City for a single metered water service; however, some strata properties require more than one metered water service.

Staff proposes to amend Part Two, Section 9, Sub-Section (a) which states "The owners of a strata development may apply to the City for a single metered water service by..." to "The owners of a strata development may apply to the City for one (or more) metered water service(s) by..."


Staff is currently preparing the Waterworks and Water Rates Bylaw for 2009 which will have this amendment; however, there are several strata titled properties that require this amendment now and cannot wait for the revised bylaw in 2009.

### Conclusion

Staff recommends that Part Two, Section 9, Sub-Section (a) of the Waterworks and Water Rates Bylaw 5637 be amended to state "The owners of a strata development may apply to the City for one (or more) metered water service(s) by..."

**Waterworks and Water Rates Bylaw 5637  
Amendment Bylaw 8442**

The Council of the City of Richmond enacts the following amendments to the Waterworks and Water Rates Bylaw 5637:

- 1. The Subsection (a) of Section 9 (Metering of Strata Titled Properties) is deleted and replaced with the following:

**PART TWO: ESTABLISHMENT AND DISCONTINUANCE OF WATER SERVICES**

9. Metering of Strata Titled Properties

- (a) The owners of a strata property development may apply to the **City** for one or more metered water service(s) by:
  - (i) submitting a resolution of the Strata Council authorizing changing to metered water service; and
  - (ii) paying the connection charge and **water** meter charge specified in Schedule D.

- 2. This Bylaw is cited as **“Waterworks and Water Rates Bylaw 5637 Amendment Bylaw 8442”**.
