Staff Report

Origin

The City of Richmond continues to enforce its Business Licence bylaws and Public Health Protection bylaws with an emphasis on the operating hours and permissive functions within the business complex. This enforcement is part of our continuous effort to promote community, customer and employee safety and to ensure that all businesses are operating in an appropriate manner consistent with City bylaws and regulations.

This report will deal with J&B Investments Ltd. dba: **Zodiac Karaoke** operating from premises located at Unit # 155 – 8291 Alexandra Road, Richmond, B.C.

Analysis

On April 17, 2008, a Show Cause Hearing was held in front of the Chief Licence Inspector. Present were Mr. Francis Yip, one of the principal owners of J&B Investments Ltd. dba: **Zodiac Karaoke**, his legal representative Mr. Peter Whyte of the law firm Lakes Straith & Whyte LLP and Mr. Victor Duarte, City Business Licence Inspector. Mr. Duarte provided both the City and the RCMP information.

J&B Investments Ltd. dba: **Zodiac Karaoke** has a valid Business Licence to operate as a Liquor Primary Karaoke Establishment and has operated this business since 1993.

The following is a summary of Mr. Duarte's information:

Ongoing inspections conducted at Zodiac Karaoke, have established that this business is continuously contravening the City's bylaws by permitting smoking in the premises. According to Inspector Duarte, "Zodiac Karaoke is currently the worst offender of the Public Health Protection Bylaw in respect to smoking violations within the City of Richmond". (Inspector Duarte Information Report attached)

This business has received two previous suspensions of their Business Licence by City Council in relation to smoking violations.

Zodiac Karaoke appeared before Chief Licence Inspector, Jim Bruce, on January 20, 2004 and subsequently received a 7 day Business Licence suspension from Richmond City Council. (February 2004 Report to Council Attached)

After this first licence suspension, **Zodiac Karaoke** accumulated an additional six MTI's for smoking violations and appeared before Chief Licence Inspector, Anne Stevens, on April 27, 2006. No licence suspension action was taken at this time.

After this hearing date, **Zodiac Karaoke** received two subsequent MTI's for smoking violations on May 18, 2006 and June 08, 2006. A Show Cause Hearing was held in front of Chief Licence Inspector Amarjeet Rattan on September 26, 2006. This resulted in a second Business Licence suspension of 14 days during the period of November 6, 2006 to November 19, 2006. (October 2006 Report to Council Attached)

Subsequent to the second licence suspension, the following violations have been documented at the business premises of **Zodiac Karaoke**:

- December 23, 2006, RCMP members and a LCLB Inspector conducted a routine inspection at Zodiac Karaoke. Cst. Shepherd observes an offence of the Public Health Protection Bylaw No 6989 and issued MTI No. 15576 under section 6.1.1.1 (a) to (k) for operator permitting smoking inside premise. This was approximately one month after the second suspension was served by Zodiac Karaoke.
- February 24, 2007, a routine inspection was conducted at **Zodiac Karaoke** by the Joint Inspection Team. Evidence of smoking occurring is documented in various karaoke rooms and MTI No. 14779 is issued to Mr. Francis Yip. Inspector Duarte enquires about smoke detectors as Mr. Yip had advised, at the last Show Cause Hearing, they would be installed in each karaoke room. Mr. Yip stated he had installed one in Room 1, but after it was damaged by patrons, he decided not to install them in the other rooms.
- August 3, 2007, at approximately 11:50 p.m., RCMP Cpl G Gillis attends Zodiac Karaoke and issues MTI No. 16626, for an observed smoking violation.
- August 4, 2007, at approximately 12:16 a.m., Sgt K. Baltus attends Zodiac Karaoke, approximately 30 minutes after Cpl G Gillis, and, issues MTI No. 16628 for a smoking violation.
- August 12, 2007, Plain clothed members entered establishment first with uniformed members trailing. At the sight of uniformed members approaching an employee of Zodiac Karaoke ran past Cst Lee, shouting "Police" in Cantonese. Cst Lee followed employee into Room 7 and observed employee collecting lit cigarettes from patrons and placing into a glass filled with liquid. Lee forwards information to Duarte for enforcement action.
- August 16, 2007, Cpl. G. Gillis, attends Zodiac Karaoke and finds smoking violations. Cpl. Gillis takes evidence to bar area to discuss with manager. Conduct of bartender becomes abusive. Alex Yip, son of Francis Yip, identified as bartender, who refers to RCMP members as 'pigs' and makes comments to patrons in a loud voice regarding "bacon". Yip identified as the only bartender in premise observed serving liquor. No Serving it Right Certificate was produced by Yip as required by the Liquor Control and Licensing Branch License Regulations. A further MTI, No 16636, was issued to Zodiac Karaoke for violations of the Public Health Protection Bylaw No 6989.
- Inspector Duarte is advised by RCMP that Zodiac Karaoke has subsequently been found
 on four separate days to be permitting smoking inside its premises. Prosecution action was
 commenced in Provincial Court by City of Richmond Crown Counsel, Jim Lees on
 September 20, 2007 (Information 51420 file attached).
- January 20, 2008, the Joint Inspection Team attends the premise of Zodiac Karaoke and finds smoking violations occurring. During this inspection, violations are noticed in the karaoke rooms as well as an individual who was smoking in the general area of the

establishment. Additional charges are added to Information 51420 file for the violations found during this inspection.

(Copies of the relevant MTI's and RCMP Statements for the above noted violations are attached.)

During the course of the April 2008 Show Cause Hearing, Mr. Whyte, solicitor for Mr. Francis Yip acknowledged that his client agrees with Inspector Duarte's information regarding the smoking violations. He stressed that the smoking problems are created by a small group of young unruly clients who do not want to obey the business staff.

Mr. Whyte indicated that his client would like to make all efforts to comply with City bylaws and towards this end has commenced a 'Corrective Action Plan' (CAP). Some of the provisions of this CAP include:

- Installing smoke detectors in all karaoke rooms
- Keeping extra smoke detectors ready to replace broken ones
- Have staff check each smoke detector daily and maintain a 'Smoke Detector Log' and a 'Communications Binder' in which problems will be recorded.
- Hire one 'security staff' who will be present from 9:00 pm 2:30 am each Friday and Saturday evening to control smoking violations.
- Install an outdoor patio heater near the front entrance to encourage clients to smoke outside.
- Establish monthly meetings with City Inspectors and RCMP to discuss issues.

With the establishment of this CAP, Mr. Whyte asked that the City refrain from imposing a licence suspension or cancellation as his client has already incurred extra financial costs by implementing the provisions of their CAP and if any further action is taken it should be limited to a 7-10 day licence suspension. "A lengthy suspension would make the business suffer and will not be manageable." He also noted that his client would like to be an important community partner by providing information on illegal drinking establishments to the City and added that "if Zodiac goes out of business, who knows what will take its place".

Mr. Yip provided a written submission in which he outlined the problem of illegal drinking establishments in the City and emphasised his willingness to "work cooperatively with the Liquor Board and the City of Richmond" with respect to eradicating these types of establishments. In this written statement, Mr. Yip also states that a lengthy suspension would make it difficult for his business to survive.

(The written submission from Mr. Francis Yip and a copy of the Corrective Action Plan are attached.)

Having considered the information provided by Inspector Duarte, the RCMP, Mr. Whyte and Mr. Yip, and, in view of the extent of new smoking violations since their second business licence suspension of November 2006, a licence suspension of 30 days for **Zodiac Karaoke** is recommended.

Financial Impact

Conclusion

J&B Investments Ltd. dba: **Zodiac Karaoke** has contravened the City's Business Licence Bylaw 7360 under Section 5.1 (b) and the Public Health Protection Bylaw No 6989 under Section 6.1.1.1 (k), for operator permitting smoking inside business premises, and, as such, their non compliance warrants a suspension of 30 days that should be enforced from July 15, 2008 through August 13, 2008, both dates inclusive.

History:

J & B Investments Ltd., doing business as, and here in after referred to as Zodiac Karaoke, operates at Unit # 155-8291 Alexandra Road. Zodiac Karaoke has operated at this location since 1993. Zodiac Karaoke is a liquor primary karaoke establishment and as such, is subject to ongoing routine inspections by the Joint Inspection Team, comprised of Liquor Control and Licensing Branch (LCLB) Inspectors, RCMP Police and City of Richmond Inspectors.

Zodiac Karaoke received a 7 day licence suspension imposed by Richmond City Council on Monday, February 9, 2004, for the period of March 1, 2004 to March 7, 2004, both dates inclusive. Zodiac Karaoke was ordered by Richmond Health Inspectors on three separate occasions to post proper non-smoking signs and informed that further evidence of smoking violations would result in the issuance of a Municipal Ticket Information (MTI). Zodiac Karaoke went on to accumulate three (MTIs) and a warning letter for violations of the Public Health Protection Bylaw No. 6989, section 6.1.1.1(a) to (k), operator permitted smoking inside premise, which resulted in this first suspension.

Zodiac Karaoke, after accumulating an additional six MTIs since first suspension, appeared at a Show Cause Hearing in front of Chief Licence Inspector, Anne Stevens, on April 27, 2006. Zodiac Karaoke assured and promised the City of Richmond that steps would be implemented to prevent smoking violations from occurring. Since this hearing date, Zodiac Karaoke was defiant again with a further two violations occurring on May 18, 2006 and June 08, 2006. An additional Show Cause Hearing was held in front of Chief Licence Inspector Amarjeet Rattan, which resulted in this second suspension. A 14 day licence suspension was imposed by Richmond City Council on Monday, October 23, 2006, for a period commencing November 6, 2006 to November 19, 2006, both dates inclusive.

Current Information:

On December 23, 2006, RCMP members and an LCLB Inspectors conducted a routine inspection at **Zodiac Karaoke**. Cst Shepherd, observes an offence of the Public Health Protection Bylaw No 6989 and issued MTI No 15576 under section 6.1.1.1 (a) to (k) for operator permitting smoking inside premise. This was approximately one month after the second suspension was served by **Zodiac Karaoke**. The fine of \$100.00 was paid on January 4, 2007. (Copy of MTI) – **Attachment 1**

On February 24, 2007, a routine inspection was conducted at **Zodiac Karaoke** by the Joint Inspection Team. Licence Inspector, Victor Duarte, observes a business employee sitting by the front door. The employee is focused on looking out front door. The employee notices the

inspection team approaching and quickly gets off her chair and rushes towards the karaoke rooms. Duarte quickly runs into business towards karaoke rooms and notices employee coming out of room # 9 and a second employee coming out of room # 2. Duarte inspects the various karaoke rooms and finds evidence of smoking occurring. Duarte proceeds to bar and lounge area and completes an MTI, No 14779, which is left with owner, Francis Yip. Duarte re-visits karaoke rooms to take photos of ashtrays. Duarte observes all ashtrays have now been removed from rooms except for room marked # 7, which Duarte observes has an ashtray still on table as well as one occupant still smoking. Duarte speaks with Yip and asks about smoke detectors, Yip had mentioned at last Show Cause Hearing, were installed. Duarte does not find any evidence to suggest smoke detectors were present in any of the rooms. Yip stated he had installed one in Room 1, but after it was damaged by patrons, he decided not to install in the other rooms. The fine of \$250.00 was paid on March 8, 2007. (Copy of MTI) – Attachment 2

August 03, 2007, at approximately 11:50 p.m., RCMP Cpl G Gillis attends **Zodiac Karaoke** and issues MTI, No 16626, for smoking violation observed of the Public Health Protection Bylaw No 6989. (Copy of MTI) – **Attachment 3**

August 04, 2007, at approximately 12:16 a.m., Sgt K. Baltus attends **Zodiac Karaoke**, approximately 30 minutes after Cpl G Gillis issues MTI. Sgt K Baltus again observes and issues an MTI, No 16628, for a smoking violation of the Public Health Protection Bylaw No 6989. (Copy of MTI) – **Attachment 4**

August 12, 2007, Cst. S. Lee, attends **Zodiac Karaoke**. Cst. Lee observes smoking violations occurring. Plain clothed members entered establishment first with uniformed members trailing. At the sight of uniformed members approaching an employee of Zodiac karaoke ran past Cst Lee, shouting "Police" in Cantonese. Cst Lee followed employee into room # 7 and observed employee collecting lit cigarettes from patrons and placing into a glass filled with liquid. A strong smell of cigarette smoke in the air was detected by Cst. Lee. Cst. Lee forwards information to Duarte for enforcement action. (Copy or Narrative) – **Attachment 5**

August 16, 2007, Cpl. G. Gillis, attends **Zodiac Karaoke** and again finds smoking violations. Cpl. Gillis takes evidence to bar area to present to manger to see first hand. Conduct of bartender becomes abusive. Alex Yip identified as bartender, who refers to RCMP members as Pigs and comments made to patrons in a loud voice regarding "bacon". Yip identified as the only bartender in premise observed serving liquor. No Serving it Right Certificate was produced by Yip as required by the Liquor Control and Licensing Branch License Regulations. A further MTI, No 16636, was issued to **Zodiac Karaoke** for violations of the Public Health Protection Bylaw No 6989. (Copy of Narrative and MTI) – **Attachment 6**

Duarte is made aware, that **Zodiac Karaoke** has been found on four separate days to be permitting smoking inside its premises. Prosecution action was commenced in Provincial Court by City of Richmond Crown Counsel, Jim Lees on September 20, 2008.

January 20, 2008, Joint Inspection Team attends the premise of **Zodiac Karaoke** and finds smoking violations occurring. Smoking does not appear to be limited to karaoke rooms. Strong smell of smoke noticed by Duarte on entry of business. Generally this is not noticed outside of karaoke room area. At this time, **Zodiac Karaoke** is awaiting trial on Information, Court file number 51420, for smoking offences and again found in violation of the Public Health Protection Bylaw. In the opinion of Duarte, the worse Duarte has seen since before the first suspension. During this inspection, violations are noticed in the karaoke rooms as well as an individual who was also noticed to be smoking in the general area, coming out of a hallway which leads to the kitchen, bathrooms and lounge areas. Additional Charge added to Information 51420 for the violation found at this inspection. (Copy of Notes and Narrative) – **Attachment 7**

January 25, 2008, LCLB Liquor Inspector Doug Dyck scheduled a meeting with the owner to obtain access to post suspension signs at business. Duarte attends at **Zodiac Karaoke** in the morning for this pre-scheduled inspection with LCLB Liquor Inspector and Provincial Health Inspector. Business was served a four day suspension from the Liquor Control and Licensing Branch violations. Duarte inspects rooms and notices that staff have not cleaned rooms from previous nights operations. Duarte observes smoking evidence from previous evening and documents with notes and photos. (Copy of notes and photos)—Attachment 8

February 7, 2008, Duarte receives a copy of "Corrective Action Plan" from counsel for Zodiac Karaoke. Counsel is hoping CAP will be accepted by City of Richmond as alternative measure to a licence suspension or cancellation. Step 6 of Zodiac Karoake's CAP is to have monthly meetings with RCMP and City of Richmond to facilitate open communication and re-establish Zodiac Karaoke's good standing in the community. Duarte informs legal counsel for Zodiac Karaoke this would not be feasible. City and RCMP could not justify monthly meetings without any clear reason other than to facilitate dialogue. (Copy of CAP) — Attachment 9

Zodiac Karaoke is currently the worse offender of the Public Health Protection Bylaw in respect to smoking violations within the City of Richmond. Zodiac Karaoke was found in violation of the Public Health Protection Bylaw No 6989 approximately one month after serving a second suspension. A further violation in February as well as four additional violations accumulated in August of 2007. While awaiting judicial process for the four violations in August, Zodiac Karaoke was found again in violation of Public Health Protection Bylaw and a fifth violation was added to Court Information 51420. Again after a further inspection conducted on January 25, 2008, evidence present of further violations of the Public Health Protection Bylaw from the previous night. In total, there has been eight violations recorded since Zodiac Karaoke served it's second suspension.

March 4, 2008, Counsel for **Zodiac Karaoke** forwards a letter confirming positive steps implemented by the Principals of **Zodiac Karaoke**. It appears that **Zodiac Karaoke** has introduced new business practices to remedy the ongoing violations of the Public Health Protection Bylaw No 6989. However, no factual evidence is available from enforcement agencies as no Bylaw or Liquor inspections have been conducted since the last offence. An inspection by Police was confirmed and conducted at Zodiac Karaoke on March 3, 2008 by the Violence Suppression Team, but the focus of the inspection was not bylaw offences. (Copy of letter and attachments) – **Attachment 10**

In careful consideration of the continuous violations of the Public Health Protection Bylaw No 6989. It is the undersigned's belief that a licence suspension or cancellation is warranted in order to prevent continuation of these offences.

Staff Report

Origin

The City continues to enforce its Business Licence bylaws and Public Health Protection bylaws with an emphasis on the operating hours and permissive functions within the business complex. These efforts for enforcement are part of our ongoing efforts to promote customer, community and employee safety and to ensure that all businesses are operating in a consistent manner so as to not prevent one business gaining an operational advantage over another business in the same business category. Various regulatory, protection services, health and federal agencies have worked together to ensure that business activities are operating within the various legislative parameters as established by these various agencies.

Analysis

City staff in co-operation and conjunction with the other agencies, continue to make unscheduled visits to adult entertainment establishments to ensure business operations comply with various legislative requirements. Many of these businesses, by the very nature of the business activity they provide are open late at night. The various agencies have, in the past, appeared before Council and expressed their concerns and have often explained how these businesses require extra staffing costs to monitor them effectively.

The Zodiac Karaoke establishment is considered an adult entertainment business. This business has received various warnings from both City and Health Board staff specifically to smoking infractions in the establishment. In fact, they have also received three municipal tickets for smoking infractions.

The business appeared before the City's Chief Licence Inspector on January 20, 2004 to review the continual disregard for the City's Public Health Protection bylaw and to be afforded an opportunity to explain their actions. A copy of the correspondence associated with this hearing is attached for Council review.

Having completed the review of all the presentation material by all parties concerned, it is the belief of the Chief Licence Inspector that a business licence suspension is warranted. The commitments that were made by the business to improve their efforts for bylaw compliance has been taken into consideration in determining the recommended suspension period.

Financial Impact

There is no direct financial impact for the City.

Conclusion

That as Zodiac Karaoke has continually ignored the City's bylaws and has received three tickets for bylaw infractions, the recommendation of a 14 day business licence suspension is warranted.

The recommended suspension will be from February 14, 2004 to February 27, 2004 both dates inclusive.

Re: Business Licence Review Hearing

This correspondence will serve as official follow up to your business licence review hearing held before me at Richmond City Hall at 3:00 pm on January 20, 2004 in Room T.2.121.

I have now had the opportunity to review all the facts as presented by Mr. Duarte of the City, your lawyer Mr. Wallace Wong and Mr. Art Hamade and Mr. Nigel Headly of the Regional Health Board.

The findings clearly indicate that you have been in contravention of the City's No Smoking Legislation and your presentation detailed your agreement with the contraventions. It was clear from the Health Board staff that this has been an on going problem with your business. Although you offered various suggestions and promises to help prevent contraventions in the future, I feel with all the past warnings and tickets issued to your business that there has been a lack of effort on your part to adhere to the rules and regulations. This being said, I feel that a business licence suspension recommendation is warranted.

I will be forwarding a report to the Richmond City Council meeting on February 9, 2004 recommending a 14 day business licence suspension commencing on February 14, 2004 and running through to February 27, 2004 both days inclusive.

The Council meeting will commence at 7:00 pm in Richmond City Council Chambers and you have the right to appear before Council to debate the recommendation and to present your case as to why the recommendation should not be supported.

Should you wish to attend to present your case, please contact Mr. Richard McKenna, the City Clerk and he will detail for you the appropriate procedures to follow.

Staff Report

Origin

The City of Richmond continues to enforce its Business Licence bylaws and Public Health Protection bylaws with an emphasis on the operating hours and permissive functions within the business complex. This enforcement is part of our continuous effort to promote community, customer and employee safety and to ensure that all businesses are operating in a consistent manner so as to prevent one business gaining an operational advantage over another business in the same business category.

This report will deal with J&B Investments Ltd. dba: Zodiac Karaoke operating from premises located at Unit # 155 – 8291 Alexandra Road, Richmond, B.C.

Analysis

On September 26, 2006, a Show Cause Hearing was held in front of the Chief Licence Inspector. Present were Mr. Francis Yip, one of the principal owners of J&B Investments Ltd. dba: Zodiac Karaoke and Mr. Victor Duarte, City Business Licence Inspector. Mr. Duarte provided both the City and the RCMP information.

J&B Investments Ltd. dba: Zodiac Karaoke has a valid Business Licence to operate as a Liquor Primary Karaoke Establishment and has operated this business since 1993.

The following is a summary of Mr. Duarte's information:

Ongoing inspections conducted at Zodiac Karaoke, have established that this business is continuously contravening the City's bylaws by permitting smoking in the premises.

This business was suspended for seven days by City Council in February 2004. The suspension was for violations of the Public Health Protect Bylaw No. 6989, section 6.1.1.1 (a) to (k), Operator permitting smoking, after receiving six additional Municipal Ticket Informations for similar violations since the 2004 suspension.

At a Show Cause Hearing on Thursday, April 27, 2006, in front of the Chief Licence Inspector, the principals of Zodiac Karaoke stressed that they would have the issue corrected within 30 days and that no further violations would occur.

Since this period, inspections conducted by Richmond RCMP on May 18, 2006 and June 08, 2006, have revealed that this business was found in both inspections to again be in defiance of the City of Richmond's, Public Health Protection Bylaw and received two additional MTI's for smoking violations.

Zodiac Karaoke paid Municipal Ticket issued on May 18, 2006. Zodiac Karaoke disputed Municipal Ticket issued on June 08, 2006, but pled guilty to a reduced fine of \$150.00 in Richmond Provincial Court on July 13, 2006.

A comprehensive statement from the Business Licence Inspector is attached for Council review.

The principal, Mr. Yip indicated that he has installed smoke detectors in the private rooms to discourage patrons from smoking. More recently he has been offering "free snacks" to patrons who comply with the smoking regulations. Despite this, he expressed frustration that some patrons still occasionally smoke in the premises despite management warnings and enforcement. Mr. Yip also outlined the financial difficulty his family will face if the business licence for Zodiac Karaoke is suspended.

A comprehensive statement from the principal, Mr. Francis Yip, is attached for Council review.

J&B Investments Ltd. dba: Zodiac Karaoke has contravened the City's Business Licence Bylaw and Public Health Protection Bylaw and as such, their non compliance warrants a suspension of 14 days that should be enforced from November 6, 2006 through November 19, 2006, both dates inclusive.

To whom it may concern:

I am here to present the case as to why our license should not suspend. We have try varieties of effort by implementing tighter security of rotating our employees for random checks in each of our rooms and the installation of smoke detectors, we have had few to almost no incidents of people who are violating the Public Health Protection Bylaw No 6968 regarding no smoking in indoor premises of Richmond, BC. Everyone on our premises are obeying this non-smoking act of Richmond when they enter Zodiac's premises as we have made it extremely clear to them that this is the law and if they don't obey it, they must go somewhere else. There have been ZERO infractions since June 08 2006 and this is clear evidence that our new strategies are working successfully in persuading our customers to follow the Public Health Protection Bylaw No. 6968.

We were striving towards making all the customers aware of the policy of smoking within the premises of Zodiac. After continuous refinement and having a group of staff with all over seven years of experience in dealing with these types of customers, we are working hard to try our best to strive toward a non-smoking environment. As opposed to other restaurant/lounge businesses where a shooting had taken place, we have had no record of violence. It is our well-trained staff of all over 7 years of experience and a business operation of 13 years that allows us to anticipate the problems and refine tactics to better suit the problems at hand. As you can see we are making an effort and I must reinforce my statement again that we are effectively making the customers obey and weeding out the ones that don't. We are not perfect but we are continuously striving towards perfection in having our business operation run smoothly with law-abiding customers as the unnecessary fines do have a toll on our business.

I know this is not easy but we have taken extreme measures in screening out the disobedient customers before they even enter our premise which has promoted the dramatic decrease in smoking within the premise. In addition, at many times, we promote the non-smoking policy by offering free snacks such as chicken wings and fruit plates to customers as long as they smoke outside the premises. This method encourages customers to smoke outside the premises and customers are adapting to it slowly and become more gradually successful as I have over management in June.

As regarding incident on May 18th, 2006, the Manager in charge of Zodiac at the time was dismissed due to poor lack of judgment and tactical usage, since then I became responsible of the management of Zodiac. In addition to fruit plates and snacks I have installed smoke detectors throughout the premises to persude the customers to obey the no smoking act. As for the June 8th 2006 incidents, I have already appeal to the judge and they have accepted my explanation and the ticket was reduced in fines. As you can see, since I have taken over in management, there have been very few disturbances among customers in regards to this law.

In addition, we really don't want the suspension to take place as my son who is going to enter UBC's medical school needs my financial support, as for elder son I have to pay his student loan since he is currently unemployed. My second brother, who is also

being supported by Zodiac, has an eight year old daughter attending a very decent elementary school, is also in need of Zodiac's business to support her schooling at one of her most crucial times of her life. We are in critical need of Zodiac's business as many people are being supported by it and like any Canadian family. I, myself, barely able to afford the mortgage that me and my wife currently have needless to say about all the other monthly expenses along with our kid's education. As you can see, we have made a great effort in stopping people from being defiant against the non-smoking law and we will continue to apply our effective tactics but I want to clear up one thing today, once and for all, that it is not us being defiant, but the odd customers that are extremely defiant. Please reconsider your current consideration in suspending us and view our past few months of history where our great efforts of stopping these by-law infringers have worked successfully. We are making an effort and despite our current success, we will continue to implement different strategies while continuing the ones that work. We absolutely do not want our license to be suspended as we are making an effort and it is working well. A suspension would seem like that the court is punishing our good and effective efforts, would it not? Thank-you for your time and I hope you will give us this chance to continue our successful efforts in persuading our customers to abide this nonsmoking by-law instead of the suspension.

This correspondence will serve as an official follow up to your business licence review hearing held before me at Richmond City Hall at 2:30 pm on September 26, 2004 in Room M.1.003

I have now had the opportunity to review all the facts as presented by Mr. Duarte, Licence Inspector for the City of Richmond and by Mr. Francis Yip for J&B Investments Ltd. The findings clearly indicate that you have been in contravention of the Public Health Protection Bylaw No. 6989 on numerous occasions. As well, your business licence was suspended by the City in February, 2004 for the same contraventions. It was clear from the information presented to me that this has been an on going problem with your business. Although you offered various suggestions and promises to help prevent contraventions in the future, it is my opinion that, based on recent contraventions, a business licence suspension recommendation is warranted.

I will be forwarding a report to the Richmond City Council meeting on October 23, 2006 recommending a 14 day business licence suspension commencing on November 6, 2006 and running through to November 19, 2006, both days inclusive.

The Council meeting will commence at 7:00 pm in Richmond City Council Chambers and you have the right to appear before Council to debate the recommendation and to present your case as to why the recommendation should not be supported. Should you wish to attend to present your case, please contact Mr. David Weber, the City Clerk at 604-276-4098 and he will detail for you the appropriate procedures to follow.

SYNOPSIS

Cpl. Gillis is a peace officer and a regular member of the Royal Canadian Mounted Police (RCMP) and he has been so since 1990. He is currently assigned with Richmond RCMP with the Richmond RCMP Detachment in the City of Richmond, Province of British Columbia

On 2007-August-16 at approximately 23:30 hrs, RCMP members attended at unit 155, 8291 Alexandra Road the location of the Zodiac Cabaret, which is owned and operated by J&B Investments Limited. The purpose of the police attendance was to check for violations of City Bylaws, Provincial Statue, and establish a no nonsense approach to illegal activity at night.

Upon entering the building Cpl Gillis proceeded to the Karoke rooms in the building. Cpl. Gillis entered room 5 and observed a male Asian smoking in violation of the bylaw. The items related to the violation were taken to the bar area and presented to the manager to see first hand the evidence.

While at the bar the bartender, Heung Fung Alex YIP, became verbally abusive to the police officers present at the scene. He made comments related to the police officers being "pigs".

Once the bylaw enforcement action was completed police undertook the liquor act investigation. The bartender was abusive to police and failed to produce a serving it right card certificate of any type. He was the lone bartender on duty.

OFFICER WILL STATES

Cpl Gillis will state:

That on Aug-16 he attended Zodiac lounge in full uniform. He did identify himself as a peace officer.

Cpl Gillis will state:

That the purpose of the police attendance was to conduct liquor and bylaw compliance;

That upon entering the building at 155 8291 Alexandra Cpl. Gillis did attend the karoke rooms and found patrons smoking contrary to the Public Health Protection Bylaw #6989.

That he observed several persons inside and smelled eigarette smoke.

That he observed a cigarette but on the floor inside the buildings.

That alcoholic beverages were being served to the patrons.

NARRATIVE

Further to Initial Information Sworn in Provincial Court on September 19, 2007:

Four Counts initially sworn on Information 51420.

Joint inspection team entered J & B Investments Ltd; doing business as Zodiac Karaoke on January 20, 2008 at approximately 02:05 hrs. Licence Inspector DUARTE found heavy smell of smoke could be detected in the hallways. DUARTE walked towards room 4 and looked inside the room. Female occupant closest to the door was smoking holding cigarette in her right hand.

Cpl. D AU got DUARTE's attention to see male occupant coming out of hallway behind bar, coming from kitchen/bathroom area with cigarette in his hand. Occupant went towards front door and out.

DUARTE moved towards room 5, 2 male occupants, closest to the door also found with cigarette in his right hand.

DUARTE moved towards room 7. Nine occupants inside. No observation of any occupants smoking but numerous cigarette butts strewn all over the floor as well as shelf on bottom of table in middle of room.

Room 4 quickly vacated by occupants once team entered establishment. DUARTE returned to room 4 entered and noticed numerous cigarette butts strewn on floor, behind seats in corner of room, as well as behind the television beside the entrance door to room. Ashes were noted to be fresh around the room as well as by one cigarette that was thrown on the floor as it was still lit and burnt another 1cm approximately on the floor with ashes still intact beside cigarette.

DUARTE spoke with individual who appeared to be in charge, identified by Liquor Inspector D. DYCK as George YIP, brother of owner Francis YIP. DUARTE informed YIP that further charges will be followed up to existing charges presently being dealt with in Provincial Court. DUARTE also mentioned that a hearing may be occurring in the near future on Licence.

Attention Chief Inspector Lee, Rattom,

This is my first attempt at a new collaboration with the City of Richmond and yourself as well in upholding the bylaws and going above and beyond to setting an example of why the bylaws should be obeyed. It is not a surprise that as a result of the non-smoking policy, many of the underground drinking places have opened up to cater to the disobedient citizens in our City. All of these places are un-licensed and cater to underage drinking, drug dealing, and an assortment of gang affiliation. One of the infamous ones is located at 4751 Garden Road on the 2nd Floor (inside Garden City Plaza). They have the locked at all times and a video camera for surveillance as a lookout for police and liquor inspectors. Victor and Doug have attempted to put an end to this place with no success as they are fore-warned from the surveillance cameras ahead of time that the officials are coming and therefore, leave through the back in the alley.

One suggestion would be to have undercover agents walk to the back and as officers are attempting the front door, the offenders have a higher chance of being caught through the back. Otherwise, another attempt could be to have fluent Cantonese speaking undercovers dressed deceivingly enter through the front and catch them in the act.

It is these flourishing underground drinking areas that are putting places like us out of business and also creating a more expansive clientele of offenders who oppose the non-smoking by-law because they are accustomed to smoking in these underground affiliations. In cooperation with you, I hope our team-work can decrease these ill places and encourage our citizens to visit the legal establishments instead of these underground homes.

I hope in this initial effort, you will realize my sincerity in being pro-active to work cooperatively with the Liquor Board and the City of Richmond. In order for our business to proceed, I hope you will realize that sometimes, giving people a chance is a better way for a long-term positive solution rather than punishment because I believe in the opportunity for change and positive differences. Our business cannot survive with a lengthy suspension such as 30 to 60 days due to the fact that our overhead is quite high and with a legacy of 15 years in the business, I would be quite sorrowful to see my business die. I encourage you to visit our establishment along with the fellow liquor inspectors to add some weight into our sincere changes and effort in working with the City in setting an example for other establishments. You are most welcome anytime for a visit or to chat about new ideas in helping not only our business but others in upholding the bylaw and dealing with unruly offenders. We will not have the chance to show a 'turning of a new leaf' if our business is put in the position to be shut-down.

Zodiac Karaoke Restaurant and Bar 155 – 8291 Alexandra Road, Richmond, BC

Background

The Zodiac Karaoke Restaurant and Bar ("Zodiac") has been in continuous operation in the City of Richmond (the "City") since 1994. Prior to 2007, Zodiac received ten Municipal Ticket Informations ("MTI"s) from the City for violations of the City's Public Health Protection Bylaw No. 6989, section 6.1.1.1(k) (the "No Smoking Bylaw").

As a result of these violations, Zodiac served two suspensions of its licence to operate. The first of these was for seven days from March 1 - 7 2004; the second was for 14 days, from November 6-17, 2006.

Between August 3 and August 16 2007, Zodiac was assessed a further four MTIs for alleged violations of the No Smoking Bylaw. On January 20, 2008, Zodiac was assessed another MTI for an alleged violation of the No Smoking Bylaw.

Given Zodiac's history of compliance problems, the City is considering either a further suspension or revocation of its licence to operate.

Zodiac is committed to remedying the current situation, and complying with the No Smoking Bylaw. This Corrective Action Plan is intended to provide the City with concrete, measurable steps and timeframes that Zodiac either has implemented or will undertake to ensure that it complies with the No Smoking Bylaw.

1. Attitude

While the vast majority of Zodiac's long term clientele are compliant with Zodiac's efforts at enforcement of the No Smoking Bylaw, a small contingent have been resistive. These individuals have at various times tampered with smoke detectors, rendering them inoperable; refused to leave Zodiac when asked by Zodiac staff; and on at least one occasion, assaulted a staff member.

Zodiac's staff and management are committed to enforcing all City by laws; Zodiac's management is further committed to ensuring that all staff enforce a "no tolerance" approach to smoking inside of Zodiac.

Implementation Date: Immediate

2. Smoke Detectors

We are instructed that new smoke detectors are now installed in the ceilings of all eleven of Zodiac's karaoke rooms, as well as one in the Lounge area. Attached as Schedule "A" to this Corrective Action Plan is a receipt for the purchase of ten new smoke detectors. The new smoke detectors will replace any inoperable units. A surplus number of smoke detectors will be kept on site, so that if any of the smoke detectors in the rooms becomes inoperable, it can be quickly replaced with a new unit.

Implementation Date: Immediate

3. Smoke Detector Monitoring

We are instructed that, while Zodiac staff and management endeavour to keep apprised of the status of smoke detectors, many smoke detectors had previously been rendered inoperable by unruly guests.

In order to address this challenge, Zodiac management commits to the immediate implementation of a **smoke detector monitoring system**. The smoke detectors will be checked each evening to ensure they are operable before Zodiac opens. The results of the smoke detector check will be recorded in a **Smoke Detector Log** (the "Log"). The Manager on shift each evening will check the Log; if a smoke detector unit is noted to be inoperable, it will be promptly replaced.

Problems with any smoke detectors will be recorded in a Communications Binder, which will be kept near the bar. It will be the responsibility of each staff member to review the Communications Binder prior to commencing his or her shift. The Manager on shift will assume responsibility for maintenance and monitoring of the smoke detectors.

Zodiac management intends to keep the Log in an area where it is easily accessible to the City's Business Licence Inspector, and invites the Inspector to review the Log during inspections to confirm compliance.

Implementation Date: February 8, 2008

4. Security

Zodiac management realize that the small contingent of its guests causes the majority of compliance problems with the No Smoking Bylaw. This small contingent has been unruly at times, and unwilling to follow the direction of Zodiac staff. In turn, Zodiac staff has been placed in the difficult position of trying to reason with these individuals, leading to unpleasant and occasionally aggressive confrontations.

In order to effectively deal with this small contingent of resistant guests, Zodiac will hire an additional dedicated Door Security Staff Member ("Security Staff"). The Security Staff will be hired on Friday and Saturday evenings, which are Zodiac's busiest nights. It is contemplated that the Security Staff shift will be from 9:00pm - 2:30am on these evenings.

The Security Staff will be tasked with ensuring general site security, including the control and management of aggressive clients and those who are in violation of the No Smoking Bylaw. The Richmond R.C.M.P. will be contacted to manage any situation that is beyond the means of the Security Staff to handle.

Implementation Date:

February 15, 2008

5. Site Management

Zodiac staff and management realize the importance of keeping their smoking clientele happy. At the same time, Zodiac management recognizes that it is incumbent upon them to ensure patrons are abiding by the No Smoking Bylaw.

Zodiac management has purchased an outdoor gas-powered patio heater in order to provide a warm area outside of Zodiac where smokers are free to congregate and smoke. The patio heater will be placed near the front door, where it will be in full view of the Security Staff and Front Door Hostess.

It is hoped that the patio heater will assist all clientele with the transition to the "no tolerance" policy demonstrated by all Zodiac staff.

Implementation Date:

February 8, 2008

6. Dialogue with R.C.M.P. and City Inspectors

Zodiac management proposes the inception of monthly meetings with City Inspectors and R.C.M.P. representatives to discuss issues of concern regarding the operation of Zodiac. It is contemplated that regular meetings will facilitate open communication between Zodiac and its community partners, and assist Zodiac in re-establishing and maintaining its good standing in the community.

Implementation Date:

March 2008

Zodiac management are committed to the enforcement of all City bylaws. It is hoped that this Corrective Action Plan will address the City's concerns with compliance, and will further allow for a dialogue that will deal proactively with future safety or compliance issues.
