Staff Report

Origin

The Richmond Seniors Advisory Committee (RSAC) was formed in 1992 to advise Council regarding the concerns and future needs of Richmond seniors. The committee studies a range of matters deemed of concern to seniors and submits information, options and recommendations to City Council. The City supports the RSAC by providing an annual operating budget, a Council liaison and a staff liaison.

This report presents the RSAC 2015 Annual Report (Attachment 1) and proposed 2016 Work Program (Attachment 2).

Analysis

2015 Annual Report

The RSAC Annual Report (Attachment 1) highlights key activities of the committee during the past year. Noteworthy examples include:

- Continued to monitor transportation issues. The transportation sub-committee also worked with Translink, Minoru Seniors Society and the City to deliver a workshop for local seniors on the Compass Card.
- Feedback on City strategies that have an impact on seniors. The RSAC provided valuable input on both the Age-Friendly Assessment and Action Plan and the Seniors Service Plan 2015-2020.
- Closely monitored housing development in the City including the completion of the construction of Kiwanis Towers and the subsequent move in of residents. The Housing sub-committee also provided input to the City on the Affordable Housing Resource Guide.

- Active involvement with many committees including Richmond Intercultural Advisory Committee, Falls Prevention, Isolated Seniors, Richmond Community Services Advisory Committee, RCMP Multicultural Advisory Committee, Poverty Response Transportation Committee, Council of Advisers for the BC Seniors Advocate and other committees concerning seniors.

2016 Work Program

RSAC will continue to provide Council with advice and recommendations on matters affecting older adults in the community and will respond to Council's requests as they arise. Highlights of the proposed RSAC 2016 plan (Attachment 2) include:


- Continue to be actively involved with many committees including Richmond Intercultural Advisory Committee, Falls Prevention, Isolated Seniors, Richmond Community Services Advisory Committee, RCMP Multicultural Advisory Committee, Poverty Response Transportation Committee, Council of Advisers for the BC Seniors Advocate, and other committees concerning seniors.
- Investigate opportunities to prevent slips, trips and falls by utilizing seniors and walking groups to identify and report trip hazards.
- Continue to gather information and educate RSAC members on issues affecting seniors in order to provide knowledge and relevant advice to City Council

Financial Impact

The RSAC operating budget of \$2500 reflects the existing funding plan, as budgeted.

Conclusion

The RSAC 2016 Work Program is designed to reflect a number of Council Term Goals (2014-2018) and address emerging issues impacting seniors in the community. The RSAC continues to advise Council on matters of concern to Richmond seniors and contributes to initiatives that aim to improve the quality of life for seniors in the city.

Purpose:

The role of the Richmond Seniors Advisory Committee (RSAC) is to act as a resource and provide advice to City Council regarding senior's issues such as health, transportation and housing as they arise or are referred by City Council. The RSAC members identify concerns of seniors and work with various community organizations and agencies, including City staff, to obtain an understanding of the issues. Information, options and recommendations are then prepared and submitted to City Council for their consideration.

In 2015, the Richmond Seniors Advisory Committee was asked by City Council to comment on both the Age-Friendly Assessment and Action Plan and the Seniors Service Plan.

Membership:

The Richmond Seniors Advisory Committee consists of 15 members including one new member. A majority of our members belong to one or more groups or

organizations, and attend numerous forums and workshops throughout the year. Members also bring to the RSAC table additional information on a broad range of topics relevant to seniors, as illustrated in the attached reports and work program. The committee is pleased to have a member appointed to the Council of Advisors for the B.C. Office of the Seniors Advocate.

Meetings:

The Richmond Seniors Advisory Committee members meet 10 times a year on the second Wednesday of the month. All meetings are open to the public. Monthly guest speakers are primarily from the non-profit sector and the provincial or municipal governments. The guest speaker's presentations provide committee members with insight into senior's issues and resources in the community. In turn, guest speakers are provided with information about the Seniors Advisory Committee. Committee members would like to thank all guest presenters that took the time to provide us with a wealth of information about their organizations.

In 2015, RSAC continued to closely monitor two issues, first, Translink's Compass Card project and second, the development of Kiwanis Towers.

In *January, 2015* RSAC discussed the draft version of the Age-friendly Assessment and Action plan and provided words/concepts for consideration such as "diversity", "inclusive", "healthy", "respect", "empowerment" and "full potential" and hoped they would be included in the vision statement or in the principles. Another suggestion from the committee was to ensure that the Action Plan is able to be measured so that it is clear that the plan is moving forward and making a difference in Richmond.

In *September, 2015* the RSAC provided feedback to the City on the draft Seniors Service Work Plan 2015-2020, which sets the goals and actions for planning and development of services and programs for seniors in Richmond for the next six years.

In *December, 2015* the RSAC Transportation sub-committee arranged a workshop with Translink to inform and educate seniors about use of the Compass card.

Heather Muter, Coordinator, Seniors Services, City of Richmond attended RSAC monthly meetings to keep committee members informed on programs and services affecting senior's health and wellbeing in the Richmond community.

Sean Davies, Acting Community Facility Coordinator, staff liaison attended all RSAC monthly meetings to provide committee members with minutes and agendas and to ensure the RSAC fulfill duties and achieve goals.

Sani Mursalim, RSAC's volunteer web master does not attend monthly meetings but ensures minutes and other information supplied to him, are posted on the RSAC web site. The RSAC web site gives the public access to the committee's role with the City and serves as a model for communities wishing to establish a similar advisory committee. The web site has received over 720 visits since monitoring commenced.

The Richmond Seniors Advisory Committee would like to thank Mayor Malcolm Brodie and Councillors for their continuing support of our committee. The committee would also like to thank Council Liaison Ken Johnston for keeping the committee members apprised of various items arising at City Council.

2015 Committee Report - Transportation

This subcommittee of the Seniors Advisory Committee has been very active over the past year dealing with and discussing issues that were very important and concerning seniors. This subcommittee works with both the Poverty Response Committee (Alex Nixon) and Richmond Gives Richmond Cares (Carol Dickson).

This subcommittee has been sending correspondence to Translink concerning many issues.

One major topic and continuing topic to be of concern is the Compass Card and what impact it will have on seniors. After taking a special course on the Compass Card and how it works, the committee chair is able to explain to seniors how the card works and ease their minds. The RSAC set up a workshop on the Compass Card in December at the Richmond Cultural Centre. This included a Translink speaker providing information on the card and other transportation concerns.

The committee is continuing to work with the City in finding easier access for seniors/persons with disabilities at major bus shelters around the City of Richmond.

Another major concern that we are currently working with City staff is the location of the bus stops and congestion at the Brighthouse Canada Line station on No. 3 Rd. This is a frightening area for seniors trying to cross No. 3 Rd. to get to Richmond Centre or Canada Line.

Transportation is a continuing concern for seniors in Richmond and the Seniors Advisory Committee will continue to liaise with other community transportation committees to work with City staff, Translink, and other organizations as much as possible to ease the concerns of the seniors.

2015 Committee Report - Fall Prevention Network

The Fall Prevention Network consists of a group of seniors and representatives from the City, health and other community services, organizations and businesses, who work together with seniors and their families to raise awareness and provide support.

The Network:

- Promotes healthy, active aging
- Encourages safety in the home and in the community
- Protects seniors' well being
- Publishes informational posters and leaflets
- Sponsors and supports numerous forums, initiatives, health fairs, etc.

The Network meets every second month, and my first meeting with the Network was on March 17, 2015. Since that date we have met May 19, September 15, and will be meeting again on November 17, 2015.

I co-chair the Network Meetings with Rishma Dhalla OT, Richmond Fall Prevention, and over the past year we have dealt with the following topics:

Community Capacity Grants by RASS, which examined the reasons why seniors avoid taking an ambulance when they have to go to the hospital. This study resulted in the publication of Ambulance Refusal Project Summary Report, which was presented to the RSAC.

The Vial of Life Initiative

Planning for the National Seniors' Day & Fall Prevention Week (November 2015). In preparation for this event the Network members prepared articles for publication in the local newspaper, which will cover a wide range of topics concerning Fall Prevention.

The VCH Community Capacity Grants were available through the VCH Regional Injury Prevention Lead.

2015 Committee Report - Housing

The housing Sub-committee has continued to monitor and report on housing issues relevant to seniors. Highlights of 2015 items reported and monitored include:

Richmond can continue to be proud of the fact that they have many new projects underway with the inclusion of Affordable Housing.

Steveston High School site is being developed with 133 townhouses, which will have approximately 10% to be allocated to Affordable Housing.

As seniors, we can only reiterate every year for Council to consider having a number of affordable housing units designated for seniors.

VanCity has a new program "Fair & Fast" Loan for people in need of money for security deposits, utility bills, etc.

RSAC provided comments on the new Affordable Housing Resource Guide to Mayor and Council and also requested RSAC be apprised of any changes that may be made to the Guide.

RSAC members (2) attended 24th Annual John K. Friesen Conference "Harnessing Technology for Aging in Place.

KFC Project (No. 3 Road and Granville Avenue) has now broken ground and we can expect completion by 2017. This is a unique project as it includes 5 various service groups having facilities to house their clients all under one roof.

We thank the City for encouraging developers to incorporate Affordable Housing in their projects.
